Proceedings of the Oneida County Board of Canvass held in the County Clerk's Office, Election Conference Room, Oneida County Courthouse, First Floor, on Friday, April 6, 2018 at 9:00 a.m. The purpose is to canvass the Spring Primary held April 3, 2018.

Notice was posted April 5, 2018, at 8:05 a.m. on the Courthouse Bulletin Board by Tracy Hartman, County Clerk per Wis Stats. Media notified April 5, at 8:10 a.m., via mail/fax/email.

Present: Heidi Nehls, Chief Deputy Clerk; Cindy Skinner, Town of Pine Lake Clerk; Tracy Hartman, Oneida County Clerk; Deb White, Town of Crescent Election Specialist and Carla Fletcher, Town of Crescent Chief Election Inspector.

Meeting/Canvass was called to order by Tracy Hartman at 9:00 a.m. Procedures utilizing "Suggested Procedures for County Boards of Canvassers" published by Wisconsin Elections Commission, January, 2018, were reviewed and agreed upon. Entries will be made into WisVote and the printed Summary Statement and Certification will be signed and mailed to the Wisconsin Elections Commission. No Provisional Ballots were issued.
