Roger Luce, Executive Director of the Oneida County Economic Development Corporation (OCEDC), explained the committee administers the U.S. Housing and Urban Development CDBG funds (Community Development Block Grant) from the federal government to the state of Wisconsin. The County applies for HUD-CDBG, the Small Cities CDBG Revolving Loan Funds Program. They are used for loans and then the funds come back to the County and we revolve those funds.

Two Hundred Fifty Thousand Dollars (\$250,000.00) and

RESOLUTION #31-2016

Resolution offered by the Supervisors of the Labor Relations Employee Services (LRES) Committee. Resolved by the Board of Supervisors of Oneida County, Wisconsin:

WHEREAS, Resolution #20-2014 did approve the Carlson Dettman Compensation Plan to be implemented for all General Municipal employees effective March 1, 2014; and

WHEREAS, the LRES Committee did indicate that there may need to be some adjustments made to the Compensation Plan once it was implemented to create a fair and equitable system; and

WHEREAS, Resolution #33-2014 did return all management positions to 1950 hours per year with benefits also based on a 1950 hour per year schedule; and

WHEREAS, the Assistant Facilities Director position had the scope of job responsibilities expanded to include the building occupied by the Tri-County Human Service Center, which is owned by Oneida County; and

WHEREAS the Buildings and Grounds Committee did authorize the Assistant Facilities Director to have an increase in salary to reflect the additional responsibilities on a temporary basis for the past eighteen months; and

WHEREAS, the Assistant Facilities Director position continues to manage an expanded scope of work the Buildings and Grounds Committee recommended to the LRES Committee that the position be moved permanently to the increased wage level, and

WHEREAS, the LRES Committee did review the recommendation of the Building and Grounds Committee and does agree that the Assistant Facilities Director position should be placed in a new grade level in the exempt wage schedule.

NOW, THEREFORE, BE IT RESOLVED, by the Oneida County Board of Supervisors that a grade level shall be added to the Exempt Wage Schedule for the Assist Facilities Director position at Grade Level K1 as follows:

RESOLUTION #32-2016

Resolution offered by the Supervisors of the Labor Relations Employee Services (LRES) Committee. Resolved by the Board of Supervisors of Oneida County, Wisconsin:

WHEREAS, due to the increased funds available from the State of Wisconsin for Routine Maintenance Agreements (RMA), Discretionary Maintenance Accounts (DMA), Local Force Agreements (LFA) and Performance Based Maintenance (PBM) for the Oneida County Highway Department; and

WHEREAS, in 2015 the Highway Department did not have sufficient staff to spend the increased money from the State of Wisconsin and had to return \$235,000 of unused funding; and

WHEREAS, the Highway Commissioner and Public Works Committee agree that two additional Equipment Operator positions would be needed to take advantage of the additional funding; and

WHEREAS, the majority of the funding for an additional two Equipment Operator positions will be covered by the additional funding from the State of Wisconsin; and

WHEREAS, the LRES Committee did review the recommendation of the Highway Commissioner and Public Works Committee and does support the creation of two full time Equipment Operator positions with the majority of costs associated with the positions to come from additional funding from the State of Wisconsin.

NOW, THEREFORE, BE IT RESOLVED, by the Oneida County Board of Supervisors that on May 18, 2016, two full time Equipment Operator positions be created at Grade Level G of the Oneida

County Non-Exempt Employee Wage Schedule with the understanding that should there be a decrease in funding the positions shall decrease accordingly.

BE IT FURTHER RESOLVED, by the Oneida County Board of Supervisors that by adoption of this resolution it shall be deemed that an amendment has been made to the County budget for fiscal year 2016 to meet all projected costs for the positions with the majority of the monies to come from additional State funding.

WHEREAS, the Oneida County Forestry Department previously identified parcel LY 1055 as a parcel for County ownership as a means to "block-in" the County Forest; and

WHEREAS, the County has negotiated with the owners of parcel LY 1055 and have agreed on a sale price of \$63,000.00; and

WHEREAS, said funds, along with necessary fees, would come from the General Fund of Oneida County; and

WHEREAS, the Forestry Department could seek future Knowles-Nelson Grant Funds from the State of Wisconsin in order to offset approximately half of the purchase price.

BE IT FURTHER RESOLVED, that the money for the purchase of LY 1055 shall come from the general fund.

Resolution offered by the Supervisors of the Forestry, Land, and Recreation Committee Resolved by the Board of Supervisors of Oneida County, Wisconsin:

WHEREAS, in accordance with the 2015-2017 state budget (2015 WI Act 55, Section 9132, page 642), the Wisconsin Department of Natural Resources (WDNR) must develop a proposal to move the headquarters of the Division of Forestry (FR-HQ) to a location north of U.S. Highway 10; and

WHEREAS, in order to identify plausible locations in northern Wisconsin to facilitate the relocation of the Division of Forestry, the WDNR is currently seeking input from municipalities interested in having the FR-HQ located in their domain; and

WHEREAS, by relocating the Division of Forestry to the "Northwoods" where the bulk of the state's forest resource and associated timber industry is located, should dramatically improve the efficiency of the forestry division by reducing travel distance and response time; and

WHEREAS, Oneida County offers a unique combination of being centrally located in the core of the state's forest resource, while having the necessary infrastructure in place to efficiently accommodate the day to day operation of the Division of Forestry; and

WHEREAS, Oneida County's role as being the central hub of the state's forest products industry is self-evident by the following agencies: Chequamegon-Nicolet National Forest, the WDNR Northern District Office, Wisconsin County Forest Association, the Great Lakes Timber Producers Association, Ponsse-North America, the American Legion Highland Forest – (Wisconsin's largest State Forest), and the field office of the Wisconsin Commissioners of Public Trust Land (BCPL), all choosing to locate their headquarters within Oneida County; and

WHEREAS, the relocation of the Division of Forestry to Oneida County would have an immediate and long lasting positive impact to our local economy through the infusion of approximately 50-70 high paying jobs, support staff, and their associated families relocating to our area, and the trickle-down effect of said agency conducting daily business within Oneida County.

NOW, THEREFORE, BE IT RESOLVED, by the Oneida County Board of Supervisors that Oneida County approves of, and would welcome, the relocation of the State Division of Forestry to any municipality located in Oneida County; and

BE IT FURTHER RESOLVED, by the Oneida County Board of Supervisors that upon adoption of this resolution the Forestry, Land, and Recreation Committee, and/or their duly appointed agent is directed to submit this resolution along with any associated support material deemed necessary the Wisconsin Department of Natural Resources for their consideration.
