Oneida County Board of Supervisors Annual Budget Hearing Meeting November 12th 2008

Chair Smith called the meeting to order at 9:30 a.m. in the County Board Meeting Room at the Oneida County Courthouse. There was a brief moment of silence, followed by the Pledge of Allegiance.

Others present: Robert Bruso, County Clerk, Brian Desmond, Corporation Counsel and John Potters, County Coordinator.

Chairman Smith reminded Supervisors to use their microphones when addressing the floor and those addressing the Board to sign the attendance form at podium.

• Accept the 2008 Annual Report – Oneida County Treasurer

Motion/second Petroskey/Cushing to accept the 2008 Oneida County Treasurer's Annual Report. All "ayes" on voice vote

• Presentation – Solid Waste Department Operations

Information Only – Bart Sexton, Solid Waste Director, briefly updated the Board on some of the programs which are going on at the solid waste site and some of the future trends. The site is a closed sanitary landfill, an active demolition landfill, an area for processing recyclables, an area for composting paper sludge and yard waste, a glass processing facility, hazardous waste operation and transfer operation. Currently, all of the garbage goes to the Marathon County Sanitary Landfill under a contract with Waste Management. The landfill was started in 1978 with a quarter of a million dollar investment. There will be a deficit in 2008 because of economic conditions and things the waste department is doing to address this include reduction in some programs, payments for recyclables are being reduced and by January 1, 2009, the reduction of 7.5 full time equivalents for employment between the County, McNaughton and Headwater employees will take place.

Land filling will be the primary means of "waste management" for the near future. The Solid Waste Department will move to a single stream recycling operation next year. Collection is 70% of the costs of garbage and recycling. "If we have to spend 20 or 30% more for processing, it's more than worthwhile in terms of the system." "This could mean charging people more or pay people less for recycling, but for haulers it will be a winner economically because their overall costs will be reduced."

Supervisor Jim Sharon arrives at approximately 10:10 a.m.

9:50 a.m. Commence public hearing on the Oneida County 2009 proposed budget. Accept/consider comments and/or correspondence from the public and take whatever action is deemed necessary. Close public hearing and continue with agenda items.

Ms. Sorenson, Finance/Auditor Director presents Preliminary Budget.

Sorenson stated that the levy will rise from \$14,748,217 to \$15,082,573, which is a 2.3 percent jump in the levy. Sorenson attributed 1.2 percent of the 2.3 percent to additions to the tax base through growth and new construction. The county's total budget of \$53,659,911 – a 3 percent increase of \$1,754,290 – is in part predicated on estimated sales tax collections of \$3,850,000. That is \$50,000 more than budgeted for this year and about \$200,000 more than the county collected in 2007. The tax rate fell by seven cents, or 3.4 percent, from \$2.03 per \$1,000 equalized value to \$1.96.

Sorenson stated that planning and zoning fees have decreased 40 percent over the past two years, while buildings and grounds increases are due to utilities. Sorenson also stated that the county is earning only about 2.25 percent on its investments compared to about 5 percent in 2007.

More discussion took place regarding the 2009 budget.

Supervisor Baier proposed cutting the UW-Extension budget monies by \$116,000 and transferring that money to the highway budget.

Motion/second Baier/Martinson to cut the UW Extension 2009 budget by \$116,000 and transfer that amount to the Highway 2009 budget.

More discussion took place.

Motion Fails.

Supervisor Holewinski proposed \$1million in excess funds to the highway department. Sorenson said the county could responsibly make that transfer, but she included words of caution.

Motion/second Holewinski/Paszak to amend the 2009 budget and to transfer the \$1million to the Highway Department and direct the highway department and committee to rework its five-year plan and spend the money accordingly.

Forest management activities will be as follows:

County Forest Cooperative Planning

The annual County Forest Cooperative Planning Meeting between the Oneida County Forestry Department (OCFD) and

the Department of Natural Resources (DNR) was held on

July 28, 2008. The purpose of the planning meeting is to provide a forum where both departments can jointly establish and agree upon County Forest Management Goals for the upcoming year. Individuals present at the 2008 County Forest Cooperative Planning Meeting were: DNR County Forest Liaison, Manny Oradei; DNR Wildlife Manager, Ron Eckstein; DNR Team Leader, Tim Friedrich; DNR Forestry Specialist, Brian Spencer; Oneida County Forest Director, John Bilogan; Oneida County Assistant Forest Director, Paul Fiene; and Oneida County Forester, Eric Rady. Items discussed were County Conservation Funds, Wildlife Habitat funds (10 cents per acre funds), proposed timber sales and harvest acreage goals, reforestation, County Forest Roads, Access Trail Seeding, surveying, forest reconnaissance, forest blocking, time standards, fish and wildlife projects, forest protection, and SFI Certification CARS and OFI's.

Timber Sale Establishment

Approximately 1400 acres of mature timber will be harvested in 20 areas as specified in Section 12 B of the forest reconnaissance computer printout. This will entail approximately 500 acres of Northern Hardwood thinning and 600 acres of Aspen harvest for regeneration. In addition, approximately 300 acres of miscellaneous timber types will also be harvested. The sale areas are distributed throughout the three County Forest Blocks (Enterprise, Cassian-Woodboro, and Lynne-Little Rice). A total sale value of \$865,000.00 is anticipated. The labor required to establish the aforementioned timber sale acreage will be provided by the OCFD in conjunction with planned assistance from DNR Forestry personnel.

Timber Sale Administration

It is anticipated that between 30 and 40 timber sale contracts will be active in the year 2009. Department involvement will include contract administration, sale inspection, and fiscal record keeping. A harvest of 20,000 cords with an equivalent value of \$865,000.00 is anticipated. The haul permit system will continue to be used for pulpwood and wood scaling will be utilized for saw logs. Weekly timber sale inspections by both County and DNR personnel will be conducted on all active sales.

Forest Reconnaissance

Forest Reconnaissance work scheduled for 2009 includes the complete revision of approximately 5,000 acres of outdated forest reconnaissance information that was collected in the 1970's and 80's. In addition, approximately 2,000 acres of forest reconnaissance data (collected in the 1990's) will be updated to reflect recent forest management activities. A combination of DNR and OCFD employees will be utilized to perform the above—described work.

A summer Limited Term Employee (LTE), paid through a 100% grant, will be used to update the oldest reconnaissance and begin digitizing the County Forest Recon Compartments in ArcMap.

Forest Protection

Cooperation with the Department of Natural Resources will be sought in protecting the forest from insects, disease, and forest fires. The U.S. Department of Agriculture, Animal Plant Health Inspection Service

(APHIS), will be contracted with to help control nuisance beaver damage. Isolated beaver colonies that have been identified as posing a threat to timber productivity, or causing damage to County Forest Roads, and Trout Streams will be targeted for capture and removal.

County Forest Roads

Additional gravel has been identified as a key priority for maintaining the high quality of our existing County Forest Road system. Consequently, locating a suitable site for future gravel crushing with low visible impact near the northern edge of the Enterprise County Forest Block will be a priority. Our culvert replacement plan is scheduled to continue in 2009. Each year approximately five to ten culverts that have reached the end of their life expectancy are scheduled for replacement. Because the majority of culverts used on the County Forest Road System are smaller in size (18-24 inch diameter), they can be installed with Forestry Department personnel and equipment. In addition to the 18-24 inch culverts scheduled for replacement in 2009 by OCFD personnel, one larger 48-inch diameter culvert is also scheduled for installation. Due it its size, the 48-inch diameter culvert will require the installation services of a contractor with larger equipment than that available to the OCFD. Normal maintenance of the other County Forest Roads will include grading, sign replacement, culvert and wash out repair, spot graveling, brushing, mowing, and beaver flood control. Access to the remainder of the forest will be determined by implementation of the access management provisions of the current Fifteen-Year Plan.

Reforestation and Plantation Release

Approximately 40 acres of established timber harvest areas will be chain scarified in order to expose mineral soil and prepare a seed bed for Oak, Maple, Pine, and Birch trees. Small irregularly shaped clear cuts ranging in size from 5-10 acres are planned for scattered areas adjacent to the Washburn Recreational Trail System. Upon completion of the aforementioned harvest, the small clear cut areas will be planted with fast growing coniferous species to provide evergreen cover along the trail. The reforestation efforts described above will greatly reduce the visual impact of subsequent timber harvests planned for the area surrounding the Washburn Recreational Trail by providing a natural visual screen of cover.

Wildlife Management

In cooperation with the Department of Natural Resources, wildlife management activity on the County Forest will center around forest openings maintenance, habitat trail mowing, seeding hunter hiking trails, and special timber sale designs to promote both game and non-game wildlife habitat. State Aid Wildlife money may be used for anchor chain scarification to promote regeneration of species beneficial to wildlife. A small allotment of State Aid Wildlife money has also been set aside to pay for landfill tipping fees generated from the disposal of trash collected from County Forest land by organized Sporting Club clean-up events.

Equipment and Facilities

In 2009, money has been budgeted to replace an existing 4x4 half-ton pickup truck. The truck will be used for forest and recreation management activities. Money has also been budgeted to replace a 29-year old 5 ft. wide brush mower. This mower is used to maintain our woodland trails for public access. Finally, money has been budgeted to replace an existing 14-year old ski trail drag. The drag is used to groom 29 miles of cross country ski trails maintained by the Oneida County Forestry Department.

WHEREAS, counties having lands entered as "County Forest Lands" under the provisions of Section 28.11(4)(b) of the Wisconsin Statutes may annually receive from the State as a non-interest bearing loan in the amount of 10—50 cents (\$0.10—\$0.50) for each acre entered in the County Forest Program to be used for the purchase, development, preservation, and maintenance of such lands; and

WHEREAS, said loan monies are repaid through a 20% severance tax on timber sales revenue coming from County Forest Lands unless a higher rate is mutually agreed to by the County and the Department of Natural Resources; and

WHEREAS, the provisions of Section 28.11(8)(b)1. enacted in 1979 made it possible for the County, at its option, to receive a payment related to meeting the needs identified in its County Forest 15-Year Plan based on a rate ranging between 10 - 50 cents (\$0.10-\$0.50) per acre; so

THEREFORE, BE IT RESOLVED, that we, the Oneida County Board of Supervisors, in consideration of meeting the needs identified in our current County Forest 15-Year Plan hereby request the Department of Natural Resources to provide the 2009 payment to the County, under Section 28.11(8)(b)1. Wis.Stats., on the basis of 50 cents (\$0.50) for each of the County's 82,000 acre forest of \$41,000.00; and

BE IT FURTHER RESOLVED that the County Clerk is hereby authorized and directed to file this request with the Department of Natural Resources prior to January 31, 2009.

Section 1. Any existing ordinances, codes, resolutions, or portions thereof in conflict with this ordinance shall be and hereby are repealed as far as any conflict exists.

Section 2. This ordinance shall take effect the day after passage and publication as required by law.

Section 3. If any claims, provisions or portions of this ordinance are adjudged unconstitutional or invalid by a court of competent jurisdiction, the

remainder of this ordinance shall not be affected thereby.

Section 4. Section <u>2.51(1)</u> of the General Code of Oneida County, Wisconsin, is amended as follows [additions noted by underline, deletions noted by strikethrough]:

2.51 COMMISSION ON AGING.

(1) COMPOSITION AND APPOINTMENT. The Commission on Aging shall consist of at least 11 but not more than 15 members, appointed by the County Board Chair, subject to confirmation by the County Board. At least 51% of the members shall be senior citizens 60 years of age or over, and at least one member shall be under the age of 30. The Commission on Aging shall consist of at least 9 but not more than 11 members, appointed by the County Board Chair, subject to confirmation by the County Board. Older individuals shall constitute at least fifty percent of the membership of this commission and individuals who are elected to any office may not constitute fifty percent or more of the membership of this commission.

BE IT FURTHER RESOLVED, should an elected official appointed to the Comprehensive Plan Oversight Committee fail to be re-elected the County Board Chairman shall appoint a replacement; and

BE IT FURTHER RESOLVED, costs of the Comprehensive Plan Oversight Committee shall be inconformity with the fiscal impact statement, which is attached hereto and made a part here of.
