Resolution offered by Land Records Committee.

Resolved by the Board of Supervisors of Oneida County, Wisconsin:

WHEREAS, Oneida County retained a 100 foot strip of land on each side of the center line of existing roads crossing the Southeast ¼ - Northeast ¼, Section 5, Township 39 North, Range 11 East, as recorded in the Register of Deeds, Volume 64 of Deeds on Page 274, Document # 109814, recorded on April 14th, 1941; and,

WHEREAS, a request has been made to Oneida County from the adjoining landowner listed in Exhibit A below requesting that a portion of said strip of land described above adjacent to Highway X be conveyed to them as they are the present adjoining owners of the land, and they have paid the \$100.00 administrative fees to process this request; and,

WHEREAS, the Town of Three Lakes has been notified of this request and the Land Records Committee recommends that the parcels described in Exhibit A be conveyed to the adjoining landowner and the right-of-way for the road be conveyed to the Town, provided the Town does not have any objection to said conveyances.

NOW, THEREFORE, BE IT RESOLVED, that the Oneida County Board of Supervisors hereby approves conveying the parcel described in Exhibit A below to the adjoining landowner and Town as listed in Exhibit A, provided that the Town of Three Lakes has no objection to such conveyances, and authorizes the County Clerk, upon receipt of the \$30 deed recording fees, to issue a quit claim deed conveying any interest the County has in the description noted below in Exhibit A.
