1 **RESOLUTION #100-2009** 2 **GENERAL CODE OF ONEIDA COUNTY, WISCONSIN** 3 ORDINANCE AMENDMENT # 4 5 6 Ordinance Amendment offered by Supervisors of the 7 **Resolutions & Ordinances/Legislative Committee** 8 9 Whereas, WI Statutes 59.10(3)(a)3 states: "Counties with a population of less 10 than 50,000 but at least 25,000 shall have no more than thirty-one supervisors, and Whereas, WI Statutes 59.10 continues: "...no later than July 1st. following the 11 12 year of each decennial census, each board shall propose a tentative county supervisory 13 district plan setting forth the number of supervisory districts and tentative boundaries....", 14 15 Whereas, a Redistricting Committee will be appointed in 2010 and will be 16 charged with creating a tentative plan for Supervisory Districts following the decennial 17 census of 2010. 18 NOW, THEREFORE, THE ONEIDA COUNTY BOARD OF SUPERVISORS 19 **DOES ORDAIN AS FOLLOWS:** 20 Section 1. Any existing ordinances, codes, resolutions, or portions thereof in 21 conflict with this ordinance shall be and hereby are repealed as far as any conflict exists. 22 Section 2. This ordinance shall take effect the day after passage and publication 23 as required by law. 24 Section 3. If any claims, provisions or portions of this ordinance are adjudged 25 unconstitutional or invalid by a court of competent jurisdiction, the remainder of this 26 ordinance shall not be affected thereby. 27 Section 4. Section 2.01 of the General Code of Oneida County, Wisconsin, is 28 amended as follows [additions noted by underline, deletions noted by strikethrough]: 29 30 2.01 RULE 1: GOVERNING BODY 31 32 (1) TITLE. The governing body of Oneida County as constituted by law shall be 33 known as the "Oneida County Board of Supervisors," hereafter referred to as 34 the "County Board" or "Board". 35 (2) SUPERVISORY DISTRICTS.
