1 Resolution offered by Supervisors of the Labor Relations and Employee Services 23 Committee 4 Resolved by the Board of Supervisors of Oneida County, Wisconsin: 5 6 WHEREAS, the Board of Supervisors of Oneida County, Wisconsin has ratified 7 resolution #81-2005, resolution #91-2006, resolution #87-2007, and resolution #97-2008 8 which renewed the community policing Deputy Sheriff position for calendar year 2006, 9 2007, 2008 and 2009; and 10 11 WHEREAS, the Sheriff will apply for a new fifty thousand dollar (\$50,000.00) 12 State of Wisconsin Community Policing grant, the 2009 award is anticipated to be fifty 13 thousand dollars (\$50,000.00), to be applied to this Deputy Sheriff position for fiscal 14 year 2010; and 15 16 WHEREAS, the Law Enforcement and Judiciary and Labor Relations and 17 Employee Services Committees are in support of continuing the Community Policing 18 Deputy Sheriff position provided the 2010 amount of fifty thousand dollars (\$50,000.00) 19 in grant monies are available to be applied to the cost of the position; and 20 21 WHEREAS, should the Community Policing Grant be awarded at an amount 22 other than fifty thousand dollars (\$50,000.00), the Sheriff's Department will notify the 23 Law Enforcement, Finance and LRES Committees for further consideration. 24 25 NOW, THEREFORE, BE IT RESOLVED, by the Oneida County Board of 26 Supervisors that the Community Policing Deputy Sheriff position is hereby renewed for 27 fiscal year 2010, contingent upon the Sheriff's department being awarded Wisconsin 28 Community Policing grant monies in the amount of fifty thousand dollars (\$50,000.00) to 29 be applied toward the cost of the position for 2010. This position will be reviewed on an 30 annual basis by the Labor Relations Employee Services Committee.
