Resolution offered by the Supervisors of the Labor Relations Employee Services (LRES) Committee.

Resolved by the Board of Supervisors of Oneida County, Wisconsin:

WHEREAS, the Sheriff's Department eliminated one Correction Officer position as part of the 2016 budget indicating if there was a return of State inmates to the Oneida County Jail the position would need to be re-created; and

WHEREAS, the Sheriff did report to the Public Safety Committee that the department was successful in negotiating a contract with the State for inmates to be housed at the Oneida County Jail; and

WHEREAS, the Public Safety Committee and the Sheriff did recommend to the LRES Committee that due to the State inmates being housed at the Oneida County Jail a Correction Officer position needed to be created; and

WHEREAS, the LRES Committee did agree with the Public Safety Committee and the Sheriff that an additional Correction Officer position should be created contingent upon the County receiving twenty (20) or more State inmates; and

WHERAS, once the threshold to create the position has been met it will be reviewed each year as part of the Sheriff Office budget.

NOW, THEREFORE, BE IT RESOLVED, by the Oneida County Board of Supervisors that a full time Correction Officer position be created once the County receives twenty (20) State inmates; and

BE IT FURTHER RESOLVED, by the Oneida County Board of Supervisors that by adoption of this resolution it shall be deemed that an amendment has been made to the County budget for fiscal year 2016 to reflect all projected costs for the positions as set forth in the fiscal impact statement which is attached hereto and made a part hereof.
