6 **Resolved by the Board of Supervisors of Oneida County, Wisconsin:**

8 **WHEREAS**, Resolution #04-10 was approved by the Oneida County Board of
9 Supervisors, which allowed the County to offer Supplemental and Additional Life Insurance
10 coverage to employees at their cost, and

11
12 **WHEREAS**, after review of said Resolution by the Department of Employee Trust
13 Funds it was discovered that the County inadvertently changed the Life Insurance Benefit at
14 Retirement which included a cost to the County, and

15
16 **WHEREAS**, during the bargaining process, Oneida County did not agree to any
17 additional cost associated with the Life Insurance Changes, therefore the Life Insurance Benefit
18 at Retirement must be restored to the prior level of benefit, and

19
20 **WHEREAS**, that pursuant to the provisions of Chapter 40 of the Wisconsin Statutes
21 such Oneida County Board of Supervisors hereby determines to be included under the following
22 Group Life Insurance program(s) provided by Chapter 40 of the Wisconsin Statute for its eligible
23 personnel:

- 24 Basic Group Insurance
- 25 Supplemental Group Life Insurance
- 26 Additional Group Life Insurance units 1, 2, and 3
- 27 Spouse & Dependent Group Life Insurance

28 ~~Amount of insurance for any insured employee who attains age 65 on or after the~~
29 ~~effective date of this resolution shall be 50% rather than 25%.~~

31 **NOW, THEREFORE, BE IT RESOLVED**, that the proper officers are herewith
32 authorized and directed to take all actions and make such deductions and submit such
33 payments as are required by the Group Insurance Board of the State of Wisconsin to provide
34 such group life insurance.

36 **BE IT FURTHER RESOLVED**, that the Oneida County WRS Agenda submit a certified
37 copy of this resolution to the State of Wisconsin Department of Employee Trust Funds.
