GENERAL CODE OF ONEIDA COUNTY, WISCONSIN
Ordinance Amendment offered by the Administration Committee.

1 Resolved by the Board of Supervisors of Oneida County, Wisconsin:
2 **WHEREAS**, it is deemed expedient and necessary that the General Code of the
3 County of Oneida, Wisconsin be brought up-to-date; and

4 **WHEREAS**, resolutions and ordinances adopted through March 20, 2012 and
5 changes necessitated by changes in State law have been incorporated into the General
6 Code by the Revisor, which has provided Oneida County with corrected printed
7 revisions, pursuant to Statute 25.08 of the General Code of Oneida County, Wisconsin;

9 **WHEREAS**, a copy of such amended General Code of Oneida County,
10 Wisconsin, has been on file and open for public inspection in the office of the County
11 clerk for not less than two weeks, as required by Statute 66.035, Wis. Stats., and notice
12 thereof has been provided by publication on May 26, 2012 in the Northwood's River
13 News;

14 **NOW, THEREFORE, THE ONEIDA COUNTY BOARD OF SUPERVISORS**
15 **DOES ORDAIN AS FOLLOWS:**

16 Section 1. The Code of Ordinances in book form entitled: General Code of
17 Oneida County, Wisconsin, as amended through March 20, 2012 shall be and hereby is
18 adopted as the general ordinances in and for the County of Oneida, Wisconsin.

19 Section 2. Any ordinance in conflict with this ordinance shall be and hereby is
20 repealed as far as any conflict exists.

21 Section 3. This ordinance shall take effect the day after passage and publication
22 as provided by law.
