**Other Business**: Hans Zietlow, Kwik Trip Representative, gave a presentation on Kwik Trip and their offer to purchase the 14 acres of land the Oneida County Highway Department site is built on. Out of the 14 acres, 5 or 6 acres will be developed for Kwik Trip and the rest will be for later development. This Kwik Trip site could open in 2017 or 2018 and would employ approximately 40 employees. The terms of the proposal have not been released due to further information needed by the County Board. Blaine Oborn, Rhinelander City Administrator, stated a tax increment financing district, or TIF district would more than likely be created and the site would be annexed into the city for water and sewer. If this land is sold, the Highway Department will need to find a new location. A 35 acre parcel in the town of Pelican is being looked at for a new site for the Highway Department. Further discussion took place and the County Board voted to seek an extension to February 2015 in order to get more information regarding Kwik Trip's offer and cost studies on a new Highway building. Chairman Hintz stated a special committee will be formed for this study.

<u>Motion/Second</u>: Sorensen/Rudolph to counter-offer Kwik Trip with an offer to postpone the acceptance date of their offer to February 1, 2015 and to have Kwik Trip respond to the counter offer by September 1, 2014.
