IFERN Radio Channel

IFERN has now gone live on the radio tower at the Law Enforcement Center. It is also in most of the department radios in the county (Base, Mobile, & Portable) Ifern is NOT a repeater frequency. At this time it is simplex only. This may change down the road. On February 24th at 18:00 we will be conducting radio testing with the departments. Each department will choose 2 locations in addition to their primary station for testing. They will be testing EMR1, IFERN, and MARC1 on their base radio, mobile radio, and a portable radio. This radio testing is expected to take 2-3 hours. An email will be forthcoming from Wayne with schedule and procedures for testing. Ken Kortenhof and Andy Beach will be working in dispatch during the testing.

What Calls in the past would have been applicable for MABAS?

Three Lakes identified 2 calls that would have been appropriate for using MABAS

- 1. Russellwood Fire 4 cabins on a windy point burned, fire jumped lake and started a brush fire that had to be accessed from other side of chain of lakes.
- MCI 3 vehicle accident Hwy 45 North and Maple Lake Dam Road multiple critical Patients, Multiple Walking Wounded – Med 10, Med 11, Med 1, Med 2, ER 91 transported patients, 2 helicopters flew Patients from Eagle River Airport
