Tina Werres also stated that the rental center in Rhinelander has proposed tent (40' x 100') rental for \$2,100.00 for the 4 days of the fair.

Plans to sell wristbands at Art on the Court House Lawn on June 12; July 4th parade; Rediculous Day August 4; Three Lakes Event August 3. Signage needed for wristband sales information.
