MINUTES OF THE FORESTRY, LAND, & OUTDOOR RECREATION COMMITTEE MEETING # 4-2010

CALL MEETING TO ORDER—At 9:00 a.m. Chair Petroskey called the meeting to order, noting that it had been properly posted in accordance with the procedures set forth by the Wisconsin Open Meeting Law.

APPROVE CURRENT AGENDA WITH THE ORDER OF AGENDA ITEMS AT CHAIR'S DISCRETION—It was moved by Rudolph, seconded by Baier, to approve the current agenda with the order of agenda items at Chair's discretion. Motion carried.

APPROVE MINUTES OF THE MARCH 3, 2010 FORESTRY COMMITTEE MEETING—It was moved by Baier, seconded by Petroskey, to approve the minutes of the March 3, 2010 meeting. Motion carried.

OPEN FISHING PIER PROPOSALS—Baier stated that he felt the opening / awarding of the fishing pier proposals should be postponed. Baier was concerned with the 100% bond up front requirement. Tom Handrick of Lakeland Landscaping was in the audience and stated that in the past only 25% bond was required and wanted to know what the reasons were for the change. Chair Petroskey stated that 4 proposals / bids had been received, and advertising for the proposals had taken place. He felt the bond percentage could be discussed and possibly changed in the future, but for this fishing pier, we should proceed with opening the 4 proposals / bids that were received. It was then moved by Rudolph, seconded by Baier, to proceed with opening the bids. Motion carried. Proposals / bids were opened, read aloud, and recorded as follows:
