CALL MEETING TO ORDER—The meeting that had been properly posted in accordance with the procedures set forth by the Wisconsin Open Meeting Law was called to order by Chair Petroskey at 9:00 a.m.

APPROVE CURRENT AMENDED AGENDA WITH THE ORDER OF AGENDA ITEMS AT CHAIR'S DISCRETION—It was moved by Thompson, seconded by Baier, to approve the current amended agenda with the order of agenda items at Chair's discretion. Motion carried.

APPROVE MINUTES OF THE APRIL 1, 2009 FORESTRY COMMITTEE MEETING—It was moved by Baier, seconded by Thompson, to approve the minutes of the April 1, 2009 meeting. Motion carried.

PERCH LAKE PARK DEVELOPMENT PROJECT

a) Open Vault Toilet Building Bids—Three bids were received, opened, read aloud, and were as follows:

It was moved by Baier, seconded by Thompson, to award the project to the low bid of \$21,785.00 submitted by All About Septics (Patrick George), pending meeting specifications and if not, to then award to second low bid of \$26,700.00 submitted by Teschendorf & Shrock, Inc. Motion carried.

- b) RASTA Fireplace Request Update—Bilogan stated that Corporation Counsel and Wiese Risk Management had advised against the fireplace, due to liability issues. However, RASTA will be providing the money for the fireplace. Guy Hansen stated that he had received one quote from R. Loduha for \$18,000.00. It was then moved by Baier, seconded by Thompson, to approve RASTA to move forward with first contacting a Fire Marshall , confer with Corporation Counsel, and depending on the outcome of those meetings, provide something in writing from the Fire Marshall and / or Corporation Counsel, prior to proceeding with coordination of construction of a fireplace. Motion carried. Bilogan stated that RASTA will be responsible for obtaining a contractor and paying the contractor, and associated work.
- c) Garland Lake Access Re-Route—Bilogan distributed a map of the Re-Route area. Oradei suggested signage to direct people to the access to Garland Lake. It was moved by Thompson, seconded by Petroskey, to approve the Garland Lake Access Re-Route. Motion carried.
- d) Fishing Pier Plans—Bilogan explained that for ADA requirements the pier would need to be 5' x 20' with an additional section 5' x 20'. Engineer stamped plans are necessary. Bilogan obtained a quote of \$1,410.00 from Tomahawk Log Homes for plans. Bilogan was waiting for a quote from Wheeler Lumber from MN. Committee Members suggested proceeding via Professional Services for the pier cost and directed Bilogan to use his discretion obtaining pier costs. Motion carried.
