**CALL MEETING TO ORDER**— At 3:30 p.m. Chair Sorensen called the meeting to order, noting that it had been properly posted in accordance with the procedures set forth by the Wisconsin Open Meeting Law.

APPROVE CURRENT AGENDA WITH THE ORDER OF AGENDA ITEMS AT CHAIR'S DISCRETION— It was moved by Van Raalte seconded by Mott to approve the current agenda with the order of agenda items at Chair's discretion. All aye. Motion carried.

APPROVE MINUTES OF THE FORESTRY COMMITTEE MEETING— It was moved by Van Raalte seconded by Zunker to approve the minutes of the December 7, 2016 FLR Committee meetings. All aye. Motion carried.

## **FOREST MANAGEMENT:**

- a) YEAR-TO-DATE TIMBER STUMPAGE REVENUE REPORT— Fiene reported that the YTD stumpage revenue was \$1,214,663.08
- b) TIMBER SALES FOR DISPOSITION—None
- c) Agreement to have a logger deliver the timber mats ordered. The mats are 4' x 16' and used for wetland crossing access. The loggers may borrow them with a deposit. Mott moved to approve the agreement, Van Raalte seconded. All aye, motion carried.

Mr. Backes spoke about the history and information about the encroachment to be addressed in the closed session. The garage was built where he felt was well within their property line. He would like to get an easement or purchase the land where the garage has encroached.
