**CALL MEETING TO ORDER**—At 9:01 a.m. Chair Baier called the meeting to order, noting that it had been properly posted in accordance with the procedures set forth by the Wisconsin Open Meeting Law.

APPROVE CURRENT AGENDA WITH THE ORDER OF AGENDA ITEMS AT CHAIR'S DISCRETION—It was moved by Martinson, seconded by Thompson, to approve the current agenda with the order of agenda items at Chair's discretion. Motion carried.

APPROVE MINUTES OF THE JANUARY 11, 2012 FORESTRY COMMITTEE

MEETING—It was moved by Berard, seconded by Thompson, to approve the minutes of the January 11, 2012 Forestry Committee meeting. Motion carried.

**UPDATE ON UTVs USING ATV TRAILS**—Bilogan stated Oneida County can opt in by resolution. It would then be up to individual towns to draft resolutions if they wish to opt out or restrict usage. Clubs would likely wait to opt in until UTV retrofits are complete.

- a) YEAR-TO-DATE TIMBER STUMPAGE REVENUE REPORT—Fiene reported that the January stumpage revenue was \$200,689.57.
- b) TIMBER SALES FOR DISPOSITION—<u>It was moved by Martinson, seconded by Thompson, to act on the following timber contracts as follows:</u>

**Contract # 1511** held by **Futurewood** was **closed** as satisfactorily completed, and refund full Letter of Credit of \$8,681.81. <u>Motion carried.</u>

**Contract # 1516** held by **Kafka Logging** was **closed** as satisfactorily completed, and refund full Letter of Credit of \$25,270.60. Motion carried.

**Contract # 1523** held by **Fink Logging** was **closed** as satisfactorily completed, and refund full Cash Deposit of \$4,884.13. Motion carried.

**Contract # 1526** held by **Twin Forest Logging** was **closed** as satisfactorily completed, and refund full Letter of Credit of \$38,158.55. <u>Motion carried.</u>

**Contract # 1527** held by **Twin Forest Logging** was **closed** as satisfactorily completed, and refund full Letter of Credit of \$30,547.72. Motion carried.

MUSSON LAND TRADE PROPOSAL—No updates reported.

BCPL LAND FOR SALE. SENE, SEC. 23 & NWNE SEC. 25, T35N-R9E. Bilogan and Fiene visited both parcels located in the Town of Enterprise, since they fit into the land acquisition guidelines. Would need appraisal and asking price. Funds might be obtained thru Stewardship grant for 50% of loan amount. Balance could be paid with a County Forest loan; repayment would require remitting 20% stumpage revenue per month. Oradei stated that application for loan needs to be in before the end of April to obtain monies during current fiscal year; later application will delay funds disbursement into August. Bilogan will gather info on the Stewardship monies, and keep Town of Enterprise informed of any actions as well.
