The following matters were taken up to wit:

- Paszak called the meeting to order for the Oneida County Public Works/Solid Waste Committee at 9 a.m. It was noted the meeting was properly posted and the media notified. Intrepidi called the meeting to order for the Oneida County Land Records Committee at 9:00 a.m. It was noted the meeting was properly posted and the media notified.
- 2. **Motion:** Cushing/Jensen to approve the agenda for the Public Works/Solid Waste Committee. All ayes. **Motion:** Intrepidi/Van Raalte to approve the agenda for the Land Records Committee. All ayes.
- 3. A tour was conducted by Bennett of the Highway Shop grounds. Bennett pointed out the age of the buildings, the areas of non-compliance, and the space constraints of the current facilities.
- 4. Committee reviewed a draft report to be presented to County Board formulated by Romportl, with information gathered from Bennett, as well as financing options provided by Sorenson/Finance Director. The report listed the areas of concerns for the existing facility, as well as options for a possible relocation of the department. Desmond explained that the county must respond to Kwik Trip's offer by August 25th. Cushing said interest rates are very low and he felt that this is a great opportunity that should not be overlooked. Jensen said that, regardless of what they decide, repairs will need to be made to the existing facility. Bennett explained that an easement to Highway 8 has been agreed upon by the property owners for \$1 for an indefinite time period. Van Raalte was told by Romportl that an appraisal of the highway property would take approximately 8 weeks. Van Raalte asked when it would be ok to make the offer public. Desmond explained that right now they are still in negotiations. Hintz said a firm offer has been made, but he doesn't know the flexibility of the offer. Romportl said at this point they would like to know if the group approves of the format of the report. Motion: Jensen/Timmons to endorse the format of the report presented for the Public Works/Solid Waste Committee. All ayes.

All Ayes. **Motion:** Van Raaltle/Zunker that because the Kwik Trip offer for the Oneida County Rhinelander Highway Department property has sufficient merit for consideration, moves that the Land Records Committee advances the offer to the full County Board. All Ayes.
