Floodplain. The Committee will be reviewing the status of map modernization. (Discussion only). Mr. Jennrich stated the Wisconsin Department of Natural Resources had an informational meeting on January 12, 2012 at the Law Enforcement Center to unveil the new Floodplain Maps. Mr. Jennrich stated that he recommended adoption of the maps because (1) they are able to be put on PV Web so people can look at them and (2) the new maps have a better scale to determine where the floodplains are. The maps are available on the Oneida County website for the public to view. Mr. Jennrich stated that there was a very good turnout for the meeting by the Towns.

## Copying of Floodplain Maps for Towns.

## 2:00 P.M. CONDUCT PUBLIC HEARING

Ordinance Amendment #1-2012 Section 9.78, Sign Regulations, authored by the Planning and Zoning Committee to amend Section 9.78, Sign Regulations, of the Oneida County Zoning and Shoreland Protection Ordinance.

The notice was published in the Northwoods River News on January 17 and January 24, 2012. The proof of publication is contained in the file. The notice was posted on the Oneida County Courthouse bulletin board on January 12, 2012. The mailing list was also read into the record.

Mr. Jennrich stated that there is no public correspondence in the file. There is correspondence from Mr. Jennrich to the Planning and Zoning Committee with carbon copies to Brian Desmond, Mark Hartzheim and Don Sidlowski. After the Notice of Public Hearing was sent out there were some comments brought up by some Staff members.

Mr. Jennrich stated that some of the changes to the Sign Regulations came about because of concerns from some of the municipalities. Mr. Jennrich went over the changes with the Committee. (Copy attached)

Gerry Inman asked about Business Directory signs on Town property showing what businesses are located on side streets. This would fall under informational signs. Mr. Inman also talked about the color of signs.

Ben Loma commented on LED lights and the size of on-premise signs. He asked about multi-tenant signs. Is it a one building structure or one property that may have more than one structure? How many signs are allowed? He asked about road grades, balloons, height exceptions, moratorium on political signs, banners and thanked the Committee about the change for "open: signs.
