- 11. **Motion:** Holewinski/Cushing to approve the WisDOT Preformance based maintenance agreement for \$100,840.22 on the Highway 8 West cracksealing project. All ayes.
- 12. **Motion:** Holewinski/Cushing to proceed with the purchase of a new Rubber Tire Roller for roughly \$71,000 as presented with the money coming from the Performance based maintenance account. Holewinski, Timmons, Cushing, Paszak ayes, Jensen opposed. Supervisor Jensen indicated he did not feel there was sufficient information to justify the purchase of a new rubber tire roller.
- 13. **Motion:** Paszak/Holewinski to proceed with the sale of a 1999 and a 2000 patrol truck using outside sources and base values of \$11,000 to \$12,000. All aye
- 14. **Motion:** Timmons/Cushing to extend the Interim Solid Waste Supervisor position until filled noting that the Solid Waste Director and Human Resources Director are working to fill the position as expediently as possible. All ayes
- 15. **No Motion:** Charbarneau reported that there has been one new applicant to date and that the LRES office will continue to review applications for the Solid Waste Supervisor positon as received. The due date for applications is March 30, 2017. Stefonek and Charbarneau are planning to set interviews for the first week of April and hope to have the position filled between the end of April and middle of May. Stefonek has the final decision. Charbarneau suggests asking Bart Sexton to sit on the interview panel and act in an advisory capacity.

- 16. **Motion:** Holewinski/Cushing to go into closed session. Roll call vote taken. All ayes. Committee went into closed session at 9:13 am.
- 17. **Motion:** Cushing/Timmons to return to open session. Roll call vote taken. All ayes. Committee returned to open session at 9:19 am.

- 19. **Motion:** Timmons/Jensen to approve a Mechanic/Operator position to be compensated at Grade Level I, Step 1 and increase to Step 2 after a favorable six- month review. All aye
- 20. Solid Waste report was not properly posted on the agenda. No report given.
- 21. Commissioner Stefonek reported things discussed at the North Central Region Commissioner meeting including safety clothing for flaggers, and State Routine Maintenance Agreements. Oneida County will host the next regional meeting. Speed zones and chip sealing will be discussed. Stefonek gave an update on the highway department construction schedule and reported that the County Highway A culverts have been received and are ready as soon as the weather permits.
