- 1. Paszak called the meeting to order at 8:00 a.m. It was noted the meeting was properly posted and the media notified.
- 2. **Motion:** Cushing/Jensen to approve the agenda. All ayes.
- 3. **Motion:** Cushing/Jensen to approve the minutes of the Public Works/Solids Waste meeting on October 23<sup>rd</sup>, 2014. All ayes.
- 4. **Motion:** Timmons/Cushing to approve Highway vendor vouchers #553-597 for a total of \$87,297.71 plus personal expense vouchers. All ayes.
- 5. **Motion:** Cushing/Timmons to accept the 2015 Wisconsin Department of Transportation Routine Maintenance Agreement in the amount of \$1,528,700 pending Corporation Counsel approval. All ayes.

Holewinski expressed concern that the updated specifications deter local companies from bidding. Bennett added that understanding and comprehension appears to be different between bid requester and bidder. **Motion:** Holewinski/Cushing to table the Construction Specifications until next meeting in order for Committee members to thoroughly read the specifications and come back with suggestions. - 9. **Motion:** Cushing/Holewinski to allow a highway LTE employee to work 37.5 to 40 hours per week during winter but not to exceed the 1200 LTE restriction. All ayes.

- 11. **Motion:** Holewinski/Jensen to approve a dollar for dollar swap of gravel from the Highway Dept for topsoil from the Solid Waste department. All ayes.
- 12. **Motion:** Timmons/Cushing to approve Solid Waste vendor vouchers for a total of \$22,997.92. All ayes.
