Call to order:

Tom Rudolph called the meeting to order at 10:10 a.m., at the Tomahawk High School, 1048 East King Road, Tomahawk, Wisconsin 54487 in accordance with the Wisconsin Open Meeting Law. Rudolph stated the proper media had been notified. Rudolph also stated for the record that notices were mailed to property owners listed by the Oneida Real Property/Tax Listing Department.

Rudolph gave a brief overview of the County's role and the timeline required by the Wisconsin State Statutes. He went over the timeline involved and the County's role in this process. Rudolph went over the rules and the time limits for people wishing to present testimony.

Discussion/decision to approve the agenda

Motion by Matteson, second by Vandervest to approve the public hearing agenda. All ayes; motion carried.

Dan Kuzlik, Department Head, for the Oneida County Agriculture & Extension Education/ Land & Water Conservation Committee; Read into the public record the County Clerk's office received and recorded 23 letters of opposition to the proposed Lake District and one letter of support for the proposed Lake District. Kuzlik stated the letters are available for public review or duplication for (\$.25 per copy) upon request.

Approximately 77 people attend this public hearing.

David Nycz

Speaker 1

in favor

David Nycz, President of the Board of Directors for the Lake Nokomis Concerned Citizens (LNCC), stated they have been working hard as an association for many years. Mr. Nycz stated the LNCC meetings are held the second Saturday of every month. The attendances at those meetings are usually the same ten to twelve people. The same few people make up approximately 90% of the workforce for the lake association. The same few people can't keep on financially and physically doing 90% of the contribution. Mr. Nycz, as a spokesperson for LNCC's expectation of the Oneida County Board is to not just hear the comments of the dozens of people at this hearing that are against the Lake District, but to hear the voices of hundreds of people that voted in favor of the formation of a Lake District that are not present here

today expect the Oneida County Board will do their job and make the lake association into a lake district. Mr. Nycz further commented that LNCC will be facing a \$40,000 - \$50,000 cost for treating Eurasian Water Milfoil in 2011. (Mr. David Nycz was allotted ten minutes to speak)

Ronald Ament

Speaker 2 in favor Ronald Ament, currently on the LNCC Board of Directors, reminded everyone present the annual lake association meeting is held annual sometime between May and September. At the annual meeting the working plan is discussed and decided what the needs are and where the work is needed for the upcoming year. Mr. Ament described what the requirements for a lake district are as required by State law. He strongly urged Oneida County Board to allow the proposed Lake District to move forward this time. (Mr. Ronald Ament was allotted ten minutes to speak)

Charles Kornack

Mr. Kornack stated he has owned property in the proposed boundaries for twenty - five years. He opposed the taxes and fees that could be levied on the property owners. It is impossible to be available to attend all the meetings. Mr. Kornack feels the State, DNR, and the County should be responsible financially not the property owners. He is opposed to the proposed Lake District. (Mr. Charles Kornack was allotted 3 minutes to speak)

Leonard Kubiatowski

Mr. Kubiatowski stated the LNCC was a good organization. Mr. Kubiatowski felt there was a need for a boat patrol. He stated he has been responsible for installing and removing buoys that have LNCC's name on them and now at his age he is becoming unable to maintain them. Mr. Kubiatowski approached LNCC on this matter and a fish kill which happened in the past and about his concerns. According to Mr. Kubiatowski he did not receive any answers or assistance. Mr. Kubiatowski is opposed to the proposed Lake District. (Mr. Leonard Kubiatowski was allotted 3 minutes to speak)

Tim Dassow

opposed Mr. Dassow spoke on the criteria needed based on four crucial points on how the Oneida County Board's is involved in the process in the final decision. Mr. Dassow emphasized the County Board has a lot of work to validate the petition signatures. He feels the LNCC is doing a good job. He also thanked the County people who are working in this process again for the second time. He commented he had been at the Courthouse to check signatures and made digital pictures of quite a few signatures on petitions. Mr. Dassow is opposed to the proposed Lake District. (Mr. Tim Dassow was allotted 3 minutes to speak)

Patricia Berg

Ms. Berg, a property owner asked several questions as to why this hearing was held in November and as to why the hearing was held at the Tomahawk High School and not the Nokomis town hall. She is concerned about the use of chemicals in the treatment of Aquatic Invasive Species and the long term consequences to the environment. Ms. Berg feels this is just more government and she is opposed to the proposed Lake District. (Ms. Patricia Berg was allotted 3 minutes to speak)

Brian Desmond, Corporation Counsel

Mr. Desmond responded as the attorney for Oneida County. Mr. Desmond explained the last hearing was held at the Nokomis town hall in May of 2008. He went to further state there was not enough room to accommodate the amount of people who attended that hearing. The fire codes were in danger of being maximized due to the amount of people who were there. In response to another question asked by Ms. Berg, Desmond explained when the hearing is held has nothing to due to the time of the year. It states under the Wisconsin State Statutes that after the signed petitions are submitted to the Clerk's Office the County has 30 day time limit to hold a hearing for the proposed Lake District. The signed petitions were submitted to the Clerk's Office on October 14, 2010 and that was the determining factor as to when the public hearing will be held. Mr. Desmond further stated it was decided to hold the hearing on a Saturday to help with getting as many people to attend as possible.

Tom Gerum

Speaker 7 Mr. Gerum is in favor of the proposed Lake District. Mr. Gerum said he is originally from Kenosha County where the weeds were permitted to grow and nothing was done to control them. The lake eventually closed up and boats were unable to navigate in the lake. (Mr. Tom Gerum was allotted 3 minutes to speak)
