No person may harvest any raw forest products, or direct the harvest of any raw forest products, from any land for which taxes are delinquent. (1m) HARVESTING UPON NOTIFICATION. (a) 1. Unless otherwise authorized to do so by the county, no person may harvest any raw forest products, or direct the harvesting of any raw forest products, from any land until **14 days** after the clerk of the county in which the land is located is notified of the person's proposal to harvest.
