Resolved by the Board of Supervisors of Oneida County, Wisconsin:

WHEREAS, a request has been made to the Oneida County Forestry, Land and Recreation Committee for an access license across County lands located in the SW ¼ NW ¼ Section 13, T37N, R7E, Town of Cassian, by the owners of the land in the SE ¼ NE ¼ Section 14, T37N, R7E, Town of Cassian; and

WHEREAS, the Forestry, Land and Recreation Committee has reviewed the aforementioned access request and determined that no significant negative impact would result to County Forest land or its users by granting an access license; so

THEREFORE, BE IT RESOLVED, that upon receipt of \$60.00 land value, \$500.00 administration fee, and \$30.00 deed recording fee, the County Clerk be authorized and directed to issue the attached access license to Todd & Renee Seidel

Resolution # 65 – 2025: Offered by the Supervisors of the Public Works and Solid Waste Committee to reimburse the Town of Stella one-half of the cost of installing a culvert over Starks Creek on Stella Lake Road.

Resolution approved for presentation to the Oneida County Board by the Supervisors of the Public Works & Solid Waste Committee

Resolved by the Board of Supervisors of Oneida County, Wisconsin:

WHEREAS, Wisconsin State Statute 82.08 provides for county aid to construct or repair municipal culverts and bridges to structures equivalent to 36” or larger with the municipality and county each paying one-half of the cost of construction or repair; and

WHEREAS, the County Board shall appropriate the sum required and shall levy a tax and when collected shall be held in an account administered by the Highway Committee; and

WHEREAS, a municipality that has voted to construct or repair a bridge or culvert may file an application for county aid with the county highway commissioner by June 30 of the year prior to project construction to be presented for approval as part of the following year’s County budget; and

WHEREAS, following an approved project’s completion the municipality shall submit a request for reimbursement that includes all invoices paid by the municipality no later than September 30 to receive reimbursement in the current year; and

WHEREAS, in 2023 the Town of Stella filed a petition and was approved for county aid for one-half the cost of installing a culvert over Starks Creek on Stella Lake Road in the estimated amount of \$80,000.00; and

WHEREAS, the Town of Stella has submitted paid invoices for cost to install the culvert over Starks Creek on Stella Lake Road for \$69,500.00; and

WHEREAS, the County’s responsibility under Section 82.08 would be one-half of \$69,500.00 or \$34,750.00;

THEREFORE, BE IT RESOLVED, that \$34,750.00 shall be paid to the Town of Stella and the money to come from the County Bridge Aid Account.

Resolution # 66 – 2025 / Ordinance Amendment # 02 – 2025: Offered by the Supervisors of the Planning and Development Committee to amend the Oneida County Code, Section 25.04 Penalty Provisions.

Resolution to amend Section 25.04 Penalty Provisions of the Oneida County General Code. Ordinance Amendment offered by the Planning and Development Committee.

Resolved by the Board of Supervisors of Oneida County, Wisconsin:

WHEREAS, the Oneida County Planning and Zoning Department administers various chapters of the Oneida County General Code, including Chapter 13 Private Onsite Wastewater Treatment Systems Ordinance and Chapter 9 Zoning and Shoreland Protection Ordinance; and

WHEREAS, Chapter 25 dictates forfeiture amounts for various violations of Oneida County's ordinances; and

WHEREAS, the Planning and Development Committee feels that subsequent consecutive violations for failure to pump and/or inspect a septic tank should result in a fine greater than the fine imposed for an initial violation; and

WHEREAS, the Planning and Development Committee feels that owners of tourist rooming houses, whether they have obtained a permit or not, should receive a greater fine to deter any violations of Chapter 9, Article 5, Section 9.58 Tourist Rooming House of the Oneida County Zoning and Shoreland Protection Ordinance; and

NOW, THEREFORE, THE ONEIDA COUNTY BOARD OF SUPERVISORS DOES ORDAIN AS FOLLOWS:

Section 1. Any existing ordinances, codes, resolutions, or portions thereof in conflict with this ordinance shall be and hereby are repealed as far as any conflict exists.

Section 2. This ordinance shall take effect the day after passage and publication as required by law.

Section 3. If any claims, provisions or portions of this ordinance are adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this ordinance shall not be affected thereby.

Section 4. Chapter 25 of the General Code of Oneida County, Wisconsin, is amended as follows [additions noted by underline, deletions noted by strikethrough]:

Section 25.04 remains the same except:
