<u>Public Comment/Communications:</u> Cooper presented a written up sample version of the PFAS resolution.

Pfizer Contract: Conlon reviewed Pfizer contract. Corporation Counsel recommended language changes to the contract indicating that it should be governed by the laws of the state of Wisconsin and the court's jurisdiction would be Oneida County, Wisconsin, and the Federal courts of the United States. Conlon stated the contract would give the health department discounts for the vaccines we purchase from Pfizer. Conlon stated we would like to sign the contract for current and future vaccines. Motion by Kelly/Fried to accept Pfizer contract as presented. Ayes: 2 (Kelly; Fried) Nays: 2 (Roach; Condado); motion failed.

Motion by Fried/Kelly to reconsider the Pfizer contract.

Lynch from Corp Counsel was asked to attend via zoom. Lynch from Corp Counsel came on via zoom and reviewed the contract and recommendations. Discussion followed. Motion made by Kelly/Fried to accept Pfizer contract for discount. All ayes; motion carried.

Tourist Rooming House (TRH) License Fees: McKinney reviewed notes provided regarding proposed license fee increase for Tourist Rooming Houses (TRH). McKinney proposed to change the TRH license fees from \$115 to \$150. Discussion followed.
