Employee Service Award:

Jennifer Chiamulera: Conlon shared Chiamulera will be celebrating her 5th anniversary with Oneida County on December 5, 2022. Conlon said Chiamulera was a great addition to the health department working in mental health, tobacco, opioid and other drug use.

Rebecca Wold: Conlon share Wold celebrated her 5th anniversary with Oneida County on November 7, 2022. Conlon said Wold took on a leadership role during the COVID pandemic. Wold has recently transitioned to the role of Public Health Supervisor.

Organization Update:

Hope Williams: Conlon introduced Hope Williams as the new Community Health Specialist Supervisor. Williams will continue to work in her position as the WIC director 50% of the time balancing this with her role as supervisor.

Staff Report - Shelby Moore:

<u>Tobacco:</u> Moore introduced as Community Health Specialist for Tobacco and the Northwoods Tobacco Free Coalition (NWTFC) Coordinator. Moore presented and reviewed handouts.

Moore stated NWTFC worked with the City of Merrill to update their local ordinance to include adding electronic cigarettes and other vaping devices and amending the current definition of smoking within the ordinance. Under the amended ordinance, the use of electronic smoking devices is prohibited in public places and places of employment, in addition to cigarettes, chewing tobacco and synthetic nicotine. The definition of smoking has been updated to include the use of an electronic smoking device.

Monthly/Quarterly Updates:

<u>Coronavirus (COVID-19) Update:</u> Conlon said the health department would finish collaborating with AMI at the church this Friday, November 11, 2022. The health department will continue offering COVID vaccines in house. COVID vaccines will most likely be available on specific days starting in December.

<u>Flu:</u> Conlon reviewed flu vaccines for this season and stated the health department has given more vaccines this year compared to previous years.

<u>Communicable Disease:</u> Conlon reviewed the communicable disease report.
