The goal is to get up and running in 2024. Funding is available through the Department of Corrections. Will need a supervising agent. Will continue with meeting with the Human Service Center, Department of Corrections, and New Provider to get OWI Court re-established.

# 8. Human Services in Oneida County Update:

Ms. Mary Rideout explained that the Oneida County Board passed the Resolution to withdraw from the Tri-County Agreement effective 12/31/2024. A consultant will be hired to assist in determining a new structure. Ms. Mary Rideout, Mr. Mike Fugle, and Sheriff Grady Hartman are meeting with the other 3 counties and also just Oneida County to figure out a plan.
