#### 1. Call to order:

# 6. Northwoods Transit Connection Update:

# 7. 2023 Approved Purchase of Service Contract for Lynn's Catering and UW Extension:

Ms. Mary Rideout explained that these are the formal contracts for Lynn's Catering and the UW Extension.

 Lynn's Catering has the 5% increase that was approved at the prior committee meeting.

- UW Extension is a contract for Health Promotion classes throughout the county. The dollar amount is not on the contract but it will be within budget.
- Motion by Ms. Rita Mahner, seconded by Mr. James Unger to approve both contracts.

# 8. Department Supervision Changes:

Ms. Mary Rideout explained that effective January 1, 2023 there will be supervision changes within Social Services and the ADRC. The on-going Children's Services supervisor will be getting a new Social Worker that was approved in the 2023 budget. The social worker to supervisor ratio is already too high in this unit. To help resolve some of this issue the two APS Workers will be moving to the ADRC and supervised by the ADRC Manager/Assistant Director. This move will have all of the Adult Workers under the same roof at the ADRC. This then frees up the Child Services Access supervisor to take on the supervision of the two Children Services Support Workers from the On-Going Supervisor. Informational only, no action needed.

### 10. ADRC Website:

# 12. Monthly Reports/Advocacy-2021 Profile of Older Americans:

The ADRC is projected to be approximately \$73,000 in the black. This helps the overall budget since Social Services is projecting a deficit of approximately \$391,000. Social Services is hoping to receive a couple of grants that will help cover the budget deficit.

Each committee member received the 2021 Profile of Older Americans, which had a publication date of November 2022. This includes a lot of data and where we are going as a population. There is an increase in older adults. We just need to make sure we have staff as the needs of our older American's increase.
