# 6. Open Public Hearing on the Oneida County Elderly/Disabled Transportation Plan for 2023:

- a. Overview of §85.21 Elderly/Disabled Transportation Plan for 2023

  Mr. Joel Gottsacker gave an overview of the plan. It is identical to the 2022 plan with the addition of Cycling Without Age, which will be funded with donations.

# 7. Approve §85.21 Transportation for the Elderly and Disabled application for 2023: Motion by Ms. Rita Mahner, seconded by Ms. Linnaea Newman to approve the §85.21 Transportation Plan as presented. All ayes, motion carried.

#### 8. Northwoods Transit Connection Update:

Ms. Barb Newman reported that the number of riders is consistent with previous years. They are fully staffed and things are going smoothly. Informational only, no action taken.

## 9. 2023 Request to Increase Food Service Contract - Lynn's Catering:

Mr. Joel Gottsacker reported that Lynn's Catering is requesting that the ADRC continue the \$0.50 per meal increase which was implemented in July of 2002; and provide a 3%-5% increase to the per meal rate in 2023 due to the cost of food and gas. With a 3% increase, it would result in an additional cost of \$22,541.69 and with a 5% increase; it would result in an additional cost of \$28,986.53. The committee felt the increase was a valid request due to the cost of food and fuel. Motion by Ms. Linnaea Newman, seconded by Mr. James Unger to approve a 5% increase above the current rate. All ayes, motion carried.

### 10. Expansion of RSVP to Vilas County - Discussion:

Mr. Joel Gottsacker reported that we underspent in the RSVP Grant. Mr. Gottsacker explained that we have a lot in common with Vilas County and would like to expand the RSVP Program into Vilas County. If is it approved by the committee he would ask for approval to expand into Vilas County. Motion by Ms. Debbie Condado to approve expanding into Vilas County and seek approval, seconded by Ms. Rita Mahner. All ayes, motion carried.

# 11. Vouchers, Purchase Orders, and Line Item Transfers:

Mr. Joel Gottsacker presented vouchers and line item transfers to the committee. Motion made by Mr. Ted Cushing, seconded by Mr. James Unger to approve the vouchers and line item transfers as presented. All ayes; motion carried.

### 12. Monthly Reports/Advocacy:

The ADRC is projected to be approximately \$65,000 in the black. This helps the overall budget since Social Services is projecting a deficit of approximately \$400,000. Social Services is hoping to receive a couple of grants that will help cover the budget deficit.
