Veterans Services:

1. CVSOA-WI Fall Conference Debrief:

Ms. Tammy Javenkoski reported that there was approximately 125 people registered for the conference. Ms. Javenkoski explained that Governor Evers formed a Blue Ribbon Commission and what the purpose of the Commission was. She also reported that Wisconsin was awarded 1.5 million dollars to assist Veterans. Not sure how much Oneida County will get or when they will get it.

She said she would forfeit her travel pay if the committee didn't approve both of them claiming it. There were no Item Transfers. Social Services:

1. Changes to 2023 Budget:

Ms. Mary Rideout stated there were not many changes to the 2023 budget. The only change is a proposed creation of a Social Services Out of Home Care Reserve (SS OHC Reserve) in the General Fund. This would need to be proposed to the County Board through Resolution. Any surplus at year-end from Social Services Fund 201 would still be transferred to the General Fund as excess tax levy; however it would first flow to the restricted set-aside fund balance up to a maximum of \$500,000. If transfers back would push the set-aside amount over \$500,000 in total, the excess then goes to the General Fund unrestricted balances. Any deficit would first pull from this restricted set-aside fund balance, and if insufficient then the General Fund unrestricted reserves would pick up the balance. The SS OHC Reserve should not have a negative balance. Informational only, no action needed.

2. Agreement to Perform Child Protective Services – Forest County Update:

Ms. Mary Rideout explained that Oneida and Langlade continue to take access calls on an every other week basis for Forest County. If the calls require

investigation than the county taking the call does the investigation. There has been instances where there were there are too many calls that required investigation so some of these are sent back to Forest County to investigate. Oneida County has also offered to assist with training Forest County staff. Staff have spent a half-day training new Forest County Staff. Informational only, no action needed.

3. Aging and Disability Resource Center (ADRC) Report:

- Cycling without Age is in the process of being established in Oneida/Vilas Counties. The Wisconsin Bike Fed's Cycling without Age Program came to Milestone Senior Living in Eagle River. In Oneida County they also went to Friendly Village and Rennes Health and Rehab to give the residents rides in the Trishaws.
- ADRC is fully staffed.
- Flu clinics are occurring at the ADRC as well as Flu clinic and COVID vaccination clinic being done at the Four Square Church.
- Medicare open enrollment has begun.
- A Volunteer Fair was done, which was poorly attended. There also was an ad in the North Star Journal which was more effective and got several calls.
- Held a Volunteer Banquet that had approximately 90 in attendance. This
 was a very nice banquet that was held at the Cabaret Cove in Rhinelander,
- Activities at the ADRC are still occurring and fitting in around the flu clinic.

4. Agency Update:

Staffing/Vacancies:

 Received 11 applications for the Administrative Support positing. Testing is being completed and interviews will be scheduled soon.

Funding Update:

 We have not yet received any information regarding the Anti-Sex Trafficking Fund or Emergency Youth Aids. We are exploring a couple of grant opportunities, one that would support Kinship (relative) placements and one that would support increased services and availability of Foster Homes for children with complex needs.

Building Project Update:

- Start demolition January 3 and will run from January 3 through January 6.
- Steel Stud Install from January 9 through January 13.
- Drywall installation and mechanical rough in's from January 16 through January 27.
- Ready for cabinets the 1st week of February
- Cabinet installation early February (if received)

Will be doing a walk-through with Building and Grounds and the Contractor before December 1, 2022 to determine what areas of the department will not be usable

by staff and/or clients. We will then develop a plan to maintain operations during the construction. We are looking at extending work from home, utilizing space at the ADRC, doubling up in available offices and utilizing other space in the courthouse.

5. 2022 Financial & Statistical Reports, Vouchers, Audit of Payments and Line Item Transfers:

The committee reviewed the Financial/Statistical Reports, Vouchers, and Audit of Payment. The projected 2022 deficit for the Department of Social Services is approximately \$477,147.

 Motion by Mr. Ted Cushing, seconded by Ms. Linnaea Newman to approve Financial and Statistical Reports, Vouchers, and Audit of Payments as presented. All ayes; motion carried.

7. Public Comment:
