Staff Report – Breanne Vos:

<u>WIC:</u> Vos introduced herself as the WIC Director. Vos reviewed the 2023 WIC annual report. Discussion followed.

Staff Report – Cami Buchmann / Kyla Waksmonski:

<u>Community Health Assessment (CHA):</u> Buchmann stated we reviewed the first part of the CHA in the last meeting. Buchmann said in this meeting we are here to review the Social Drivers / Social Determinants of Health and Health Behaviors.

Conlon said we look at all of the social determinants of health. Conlon stated Health Care access is an issue because many people are not making it to the doctor, do not have access and/or are having difficulty finding a physician. Additionally, Conlon said housing and childcare were selected as priorities for the CHA.

Buchmann indicated there is recreation data in the report and a mention of community safety. In the report, the data focuses on alcohol use, which speaks to

the health behaviors we see, specifically focusing in on how many of our county binge drinks. Buchmann also said we have a bigger picture of substance use in youth. Discussion followed.

Buchmann said at the next meeting the last part of the CHA which is Health Conditions will be reviewed.

<u>Health Hazards:</u> Wold reviewed 2023 health hazard annual report in its entirety. Discussion followed.
