In accordance with ch. NR 130.06 Wis. Adm. Code, the Department is hereby issuing a license to Badger Minerals, LLC, a subsidiary of Can-America Minerals, Inc. of Thunder Bay, Ontario, Canada (# 40003), for the purpose of conducting metallic mineral exploration in the State of Wisconsin. The complete application form was submitted to the Department on January 29, 2020 along with proof of liability insurance, a report of the company's assets and liabilities, a copy of a bond payable to the Department, and a \$300.00 application fee.
