Meeting Notice was posted February 19, 2020, at 8:55 a.m. on the Courthouse Bulletin Board by Tracy Hartman, County Clerk per Wis Stats. Media notified February 19, 2020 at 8:55 a.m., via mail/fax/email.

Present: Heidi Nehls, Chief Deputy Clerk; Cindy Skinner, Town of Pine Lake Clerk; and Carla Fletcher, Town of Crescent Chief Election Inspector.

Meeting/Canvass was called to order by Cindy Skinner at 9:00 a.m. Poll lists with supplemental lists, absentee ballot logs, tally sheets, tapes, and Inspector's Statements will be reviewed. Voter/ballot numbers to be checked for accuracy and compared to election night report. Forms to be checked for signatures and correct completion. Notations will be made below and municipal clerks will be contacted. The Tabular Statement of Votes Cast will be filled in after each municipality is reviewed. Upon completion of the reviews, the election night results will be reconciled for any errors and the Summary Statement of the Board of Canvassers along with the Certification will be completed and signed by the board and will be made a part of these minutes.
