Proceedings of the Oneida County Board of Canvass held in the County Clerk's Office, Oneida County Courthouse, First Floor, on Friday, August 16, 2024 at 9:00 a.m. The purpose is to canvass the Partisan Primary held August 13, 2024.

Meeting notices were posted and media was notified by Tracy Hartman, County Clerk per Wis Stats.

Meeting/Canvass was called to order on Friday, August 16, 2024 by Tracy Hartman at 9:00 a.m.

Present: Tracy Hartman, County Clerk; Cindy Skinner, Town of Pine Lake Clerk; Heidi Nehls, Chief Deputy Clerk; Carla Fletcher, Town of Crescent Chief Election Inspector.

Poll lists with supplemental lists, absentee ballot logs, tally sheets, tapes, and Inspector's Statements will be reviewed. Voter/ballot numbers to be checked for accuracy and compared to election night report. Forms to be checked for signatures and correct completion. Notations will be made below and municipal clerks will be contacted. The Tabular Statement of Votes Cast will be filled in after each municipality is reviewed. Upon completion of the reviews, the election night results will be reconciled for any errors and the Summary Statement of the Board of Canvassers along with the Certification will be completed and signed by the board and will be made a part of these minutes. Entries will be made into WisVote and the printed Summary Statement and Certification will be signed and mailed to the Wisconsin Elections Commission.

Town of Cassian – Voters – 292/ Ballots Cast – 292

Absentee total was not listed on the Certification Page. Last voter number was not circled. No Tally Sheet for write-ins. Optical Scan number not listed on Inspectors Statement. EDR total was listed as 11 and should be 12.

Town of Crescent – Voters – 545/ Ballots Cast – 545

All reports signed and completed correctly.

Town of Enterprise – Voters – 104/ Ballots Cast – 104

No names were listed on the handwritten tally sheet.

Town of Hazelhurst – Voters – 395/ Ballots Cast – 395

No tally sheet for write-ins. Voter total, EDR totals and Absentee total not listed on Inspectors Statement. Handcount total on Inspectors Statement should be zero as there were no handcounts.

Town of Lake Tomahawk – Voters – 313/ Ballots Cast – 313

No tally sheet for write-ins.

Town of Little Rice – Voters – 96/ Ballots Cast – 96

All reports signed and completed correctly.

Town of Lynne – Voters – 36/ Ballots Cast – 36

All reports signed and completed correctly.

Town of Minocqua – Voters – 1615/ Ballots Cast – 1614

Voters exceed number of ballots. No tally sheet for write-ins.

Absentee total not listed on Certification Page. Last voter number not circled. No tally sheet for write-ins. EDR total listed on Inspector's Statement was 4 and 5 should have been listed.

Town of Newbold (Ward 1) – Voters – 89/ Ballots Cast – 89

Inspectors Statement not initialed by Chief Inspector. Serial Number from bag not listed on Inspectors Statement.

Town of Newbold (Ward 2, 3, 4) – Voters – 721/ Ballots Cast – 721

Serial Number from bag and initials from Chief Inspector missing from Inspectors Statement.

Town of Nokomis – Voters – 409/ Ballots Cast – 409

Absentee total not correct on Certification Page. No tally sheet for write-ins. Optical Scan number not listed on Inspectors Statement.

Town of Pelican – Voters – 631/ Ballots Cast – 631

All reports signed and completed correctly.

Town of Piehl – Voters – 22/ Ballots Cast – 22

Tally sheet for write-ins not completed. EDR total not listed on Inspectors Statement. There was one more ballot than voter. Town Clerk documented that voter cast a blank ballot on accident and was issued a second ballot. County canvassers opened ballot bag and drew down the blank ballot. Tape was updated to reflect 22 ballots.

Missing initials by Chief Inspector on Inspectors Statement. Serial number from bag not listed on Inspectors Statement.

No handwritten tally sheet for write-ins.

Town of Stella – Voters – 183/ Ballots Cast – 183

All reports signed and completed correctly.

Town of Sugar Camp – Voters – 530/ Ballots Cast – 530

All reports signed and completed correctly.

Town of Three Lakes – Voters – 679/ Ballots Cast – 679

No handwritten tally sheet for write-ins.

Town of Woodboro – Voters – 272/ Ballots Cast – 272

Missing optical scan number from Inspectors Statement. EDR total was not correct.

Town of Woodruff – Voters – 558/ Ballots Cast – 558

Handcounted ballots not added to tally sheet. Serial number from bag not listed on Inspectors Statement.

City of Rhinelander – Voters – 1258/ Ballots Cast – 1258

All reports signed and completed correctly.

Reconciliation completed, information was recorded in WisVote and the Certification was signed.
