**1. Call to Order:**

The regular meeting of the Criminal Justice Coordinating Committee (CJCC) was brought to order at 12:00 p.m. by Mr. Steven Schreier, Chairperson. The Chairperson noted that the meeting had been properly posted and mailed in accordance with the Wisconsin Open Meeting Laws.

**2. Approval of Agenda:**

Motion by Mr. Tyler Young, seconded by Judge Bloom to approve the agenda as posted. All ayes; motion carried.

**3. Review of Minutes from March 14, 2024 CJCC Meeting:**

Motion by Ms. Jillian Pfeifer, seconded by Mr. Tyler Young, to approved the March 14, 2024 minutes as presented. All ayes; motion carried.

**4. Presentation – Comprehensive Opioid, Stimulant and Substance Use Program (COSSUP) Grant – Jennifer Chiamulera – OC Public Health:**

Ms. Jennifer Chiamulera presented Overdose Prevention and Strategies of the COPE (Community, Outreach, Prevention, and Education) Coalition – Substance Use Subcommittee and the Overdose Data to Action Grant focus on preventing harm associated with opioid overdose and implementing evidence-based approaches to intervention and referral to treatment at multiple intercepts of the criminal justice system.

The Oneida County Community Response Team (OC CRT) utilizes Peer Recovery Coaches (PRC) and the unique contacts of first responders to deflect individuals

experiencing substance use concerns and impacted family members to the care they feel they need.

**Reported Benefits:**

- Increase access to Recovery Resources.
- Improved Relationships and Trust.
- Enhance Recovery Outcomes
- Decrease Criminal Justice Involvement

Looking to the Future – 2024 – Oneida County Health Department wrote for a Comprehensive Opioid, Stimulant and Substance Use Program Grant in 2023. The funding will help advance current programming and recovery housing in Oneida County.

Oneida County Health Department is now a NARCAN direct provider. This service will increase access by training and distributing NARCAN to family members and organizations serving people who are experiencing substance use concerns.

It was discussed that this would fit under the CJCC as a sub-committee. Motion by Mr. Lloyd Gauthier, seconded by Judge Bloom to have this be under the CJCC as a sub-committee. Ms. Chiamulera will put together who the members of the sub-group would be and bring to the next meeting.

**5. Sub-Committee Updates:**

a. Diversion Sub-Committee:

- First participant moved into Phase 3
- First status review hearing for a participant
- Eight participants calling in to drug testing line; random drug testing (2 calling in/testing in Vilas County).
- Coordinator compiled information on jail overview for subcommittee
- OC/VC Team met with Family Health Center staff (director and treatment providers) on March 8, 2024.

Current Active Participants: 8 (7 in Phase 1; 1 in Phase 3)

Others: 1 had been assessed and is awaiting hearing/legal agreement; 2 are deciding on residency/participation; recent referral with no contact with JP; 1 has had no contact with Justice Point for over 30 days and will receive a notice/deadline to make contact this week, 2 are awaiting attorney advice/decision to participate.

YTD successfully discharged: 0

YTD withdraw/terminated: 0

- b. OWI Court Sub-Committee: The group is working on updating the Handbook with hopes to have it finished soon. The procurement plan we are waiting for the Department of Corrections as well as a provider.
- c. Funding Sub-Committee: The sub-committee is prioritizing and will be bringing to the CJCC recommendations to start using some of the opioid dollars. If there is any feedback from the CJCC on prioritizing or things that should be added let someone from the committee know. The opioid dollars can also be used for match for other grants as long as it is within the allowable uses of the opioid settlement funds..
- 6. 2024 Meeting Schedule – move to Every Other Month:**  
It was proposed that the CJCC meet every other month for the rest of 2024. This gives sub-committees more time. Motion by Mr. Lloyd Gauthier, seconded by Ms. Jillian Pfeifer to meet every other month. All ayes, motion carried. Next CJCC Meeting will be in June.
