## Announcement of any action taken in closed session:

Timmons stated that the committee supported the Forestry, Land & Recreation Committee's decision to decline the offer from TowerPoint for the Luber Land Cell Tower Lease topic; the committee approved the request in the topic of Deputy Register of Deeds I and Deputy Register of Deeds I Compensation; the committee approved the closed session minutes from June 13, 2023.

Wisconsin Public Service request for temporary (1 year) easement for electric and gas service at 7450 CTH K over County-owned land, parcel # WB-3-1 in the Town of Woodboro, being part of SWNE, Section 1, Township 36 North, Range 7 East.

Timmons explained the two different easements topics and why there is a need for utilities to be placed at the Oneida County Solid Waste Site. Chiamulera distributed the easement and the resolution for review.

Discussion on Chapter 16 Road Naming and Uniform Addressing System proposed ordinance amendments. Chiamulera and Hilgendorf presented to the committee the concerns and possible issues that arise with regards to addressing within campgrounds under the current addressing ordinance. The committee reviewed multiple campgrounds as examples to discuss different situation that arise with addressing. The committee issued guidance with how to proceed with the situation at this time, potentially modifying the County Address Ordinance to reflect campground situations.
