Resolved by the Board of Supervisors of Oneida County, Wisconsin:

WHEREAS, the Planning and Development Committee having considered Rezone Petition 2 – 2019 (copy attached), which was filed February 25, 2019, to amend the Master Zoning District Document and the Oneida County Official Zoning District Boundary Map, and having given notice thereof as provided by law and having held a public hearing thereon June 5, 2019 pursuant to Section 59.69(5), Wisconsin Statutes, and having been informed of the facts pertinent to the changes which are as follows:

To rezone land from District # 1A – Forestry to District # 02 – Single Family Residential on property described as the NW SE and part of SE NW, SW NE, SE NE, NE SW, lying south of Pine Lake Road and east of Swamsauger Heights Road, Section 10, T38N, R4E, Town of Minocqua, Oneida County, Wisconsin.

And being duly advised of the wishes of the people in the area affected as follows:

WHEREAS, the owner of the property wants to build a year round permanent residence and;

WHEREAS, the current zoning designation of District #1A-Forestry only allows seasonal use of the property and;

WHEREAS, the proposed rezone is in compliance with the future land use plan for the Town of Minocqua and;

WHEREAS, the Town of Minocqua approved the request (copy attached) and;

WHEREAS, On June 5, 2019 the Planning and Development Committee held a public hearing and the adjoining landowners were provided with a written notice of the change and;

WHEREAS, one neighboring property owner voiced concern with the rezone petition because he currently does not have access to his parcel and:

WHEREAS, the Planning & Development Committee has reviewed the general standards as specified in Section 9.86(F) of the Oneida County Zoning & Shoreland Protection Ordinance and concluded that the standards have been met. The Planning & Development Committee recommends passage.

NOW THEREFORE, THE ONEIDA COUNTY BOARD OF SUPERVISORS DOES ORDAIN AS FOLLOWS: Petition # 2 – 2019:

Section 1: Any existing ordinances, codes, resolutions, or portion thereof in conflict with this ordinance shall be and are hereby repealed as far as any conflict exists.

Section 2: The ordinance shall take effect the day after passage and publication as required by law.

Section 3: If any claims, provisions, or portions of this ordinance are adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of the ordinance shall not be affected thereby.

Section 4: Rezone Petition #2-2019 is hereby adopted amending the Master Zoning District Document and the Oneida County Official Zoning District Boundary Map, by changing the zoning district classification from District #1A – Forestry to District #02 – Single Family Residential on property described as follows:

NW SE, and part of SE NW, SW NE, SE NE, NE SW, lying south of Pine Lake Road and east of Swamsauger Heights Road, Section 10, T38N, R4E, Town of Minocqua, Oneida County, Wisconsin.

The County Clerk shall, within seven (7) days after adoption of Rezone Petition # 2 – 2019 by the Oneida County Board of Supervisors, cause a certified copy thereof to be transmitted by mail to the Minocqua Town Clerk.

WHEREAS, the Oneida Vilas Transit Commission currently leases a 2007 Chevrolet bus (VIN 1GBE5V1217F41076) for \$1.00 from Oneida County and operates and maintains the bus to provide transportation services; and

WHEREAS, the bus was purchased by Oneida County Department on Aging using §85.21 funds; and

WHEREAS, titles for all other passenger vehicles previously owned by Oneida County have been transferred to Oneida Vilas Transit Commission; and

WHEREAS, transfer of title from Oneida County to the Oneida Vilas Transit Commission for this vehicle will complete the transfer of all vehicles, release Oneida County from liability of owning the vehicle, void the lease arrangement, is allowed by the Wisconsin Department of Transportation, and is in the spirit of the §85.21 Transportation grant;

THEREFORE, BE IT RESOLVED, that the Oneida County Board of Supervisors approves the transfer of title of the above passenger bus to the Oneida Vilas Transit Commission and authorizes and directs the County Clerk to sign and release title and possession of same.

Resolution # 62 – 2019/Ordinance Amendment # 14 – 2019: Offered by the Supervisors of the Public Works Committee amending section 7.07 of the General Code – Speed Zone.

Ordinance Amendment offered by the Public Works Committee.

WHEREAS, traffic conditions on County Highway L in the Town of Nokomis were reported to be dangerous; and WHEREAS, it was requested that the speed limit in that area be reduced from 55 m.p.h. to 45 m.p.h.; and WHEREAS, it is necessary for Oneida County to amend their ordinances in order to put the new speed limits into effect. NOW, THEREFORE, THE ONEIDA COUNTY BOARD OF SUPERVISORS DOES ORDAIN AS FOLLOWS:

Section 1. Any existing ordinances, codes, resolutions, or portions thereof in conflict with this ordinance shall be and hereby are repealed as far as any conflict exists.

Section 2. This ordinance shall take effect the day after passage and publication as required by law.

Section 3. If any claims, provisions or portions of this ordinance are adjudged unconstitutional or invalid by a court of competent jurisdiction, the

remainder of this ordinance shall not be affected thereby.

Section 4. Section <u>7.07</u> of the General Code of Oneida County, Wisconsin, is amended as follows [additions noted by underline, deletions noted by strikethrough]:

7.07 SPEED ZONE. (Rn. # 77 - 2000)

Based upon a traffic investigation conducted by the Oneida County Highway Commissioner, the maximum permissible speed at which vehicles may be operated on the following described highways, which is established as reasonable and safe pursuant to §349.11, Wis. Stats., shall be effective, subject to approval by the State Highway Commission and upon erection of standard signs giving notice thereof:

(1) 45 MPH.

CTH "L", from the south county line limit, northerly for a distance of approximately 3.65 mile, to Rocky Road, and 55 mph from a point of approximately 3.65 miles from the south county limits to the junction of US Highway 51 and CTH "L".

CTH "D", between the bridge over the channel between Chain and Echo Lakes and CTH "H". (Cr. Res. # 94 - 91)

CTH "G", between its junctions with CTH "Q" and US 45. (Cr. # 72 – 85)

CTH "J", from Fischer Landing Road east to the junction of STH 70. (Cr. # 107 – 99)

CTH "Q", between its junction with CTH "G" and US 45. (Cr. # 72 – 85)

STH 13, between its junction with CTH "G" and US 45. (Cr. # 72 – 85)

STATION 134 to STATION 176, a distance of 4,200 feet. (Cr. Res. # 2 – 92)

CTH "D" from a point 0.08 miles northeast of its junction with West Bluebird Road easterly to a point 0.02 miles southwest of its junction with Bird Lake Road.

CTH "D" from a point 0.19 miles east of its junction with Rainbow Road easterly to a point 0.05 miles west of its junction with Elm Road.

(2) 35 MPH

CTH "G", from the south corporate limits of the City of Rhinelander, southerly for a distance of 0.4 miles, and 45 mph from a point 0.4 from the south corporate limits of the City of Rhinelander to a point 300' south of the junction of the entrance road to the Lake Julia Campus of Nicolet College and Technical Institute and CTH "G".

CTH "J", from its junction with US 51 to its junction with STH 47. (Am. Res. #60-94)

CTH "J", from STH 47 east to Fischer Landing Road. (Cr. #108-99)

CTH "J", from Pinewood Drive to North Rainbow Drive. (Cr. Res. #85-2000)

CTH "D" from a point 0.02 miles southwest of its junction with Bird Lake Road easterly to a point 0.19 miles east of its junction with Rainbow Road.

(3) 40 MPH.

CTH "K", from its intersection with STH 47 easterly to the west corporate limits of the City of Rhinelander.

<u>Motion/Second Liebert/VanRaalte</u> to amend line 33 to say "northerly to a distance of Point of Pines Road" and strike the remainder of line 33, line 34 and line 35.

<u>Discussion:</u> Jensen went over the reduction in the speed in that area, discussion ensued as to the reasoning for the reduction. Discussion of whether the town supported the original Resolution. Timmons recommended that this be sent back to the town requesting a recommendation.

<u>Resolution # 66 – 2019:</u> Offered by the Supervisors of the Conservation and UW-Extension Education Committee adopting the Land and Water Resource Management Plan.

Resolution approved for presentation to the Oneida County Board by the Supervisors of the Conservation and UW-Extension Education Committee.

Resolved by the Board of Supervisors of Oneida County, Wisconsin:

WHEREAS, Section 92.10 of the Wisconsin Statutes created a state land and water management planning program, whereby each county must prepare a county land and water resource management plan; and

WHEREAS, to meet this requirement, the Oneida County Conservation and UW-Extension Education Committee has initiated a planning process to update and revise the existing Oneida County Land and Water Resource Management Plan, adopted through Resolution No. 007-2012 on January 17, 2012; and

WHEREAS, to be eligible to receive soil and water resource management grant funds from the Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP), Oneida County must submit an annual workplan and funding request based upon an approved Land and Water Resource Management Plan.

WHEREAS, this plan has been updated following prescribed procedures for public participation, with significant input from an advisory committee of affected stakeholders representing a broad range of economic and environmental interests; and **WHEREAS**, the purpose of the revised plan is to do the following:

- 1. Define local environmental issues of priority concern; and, to establish local, natural resource management goals and conservation program objectives.
- 2. Provide an implementation framework and activity schedule that will be applied to pursue the natural resource management goals, as defined.
- 3. Serve as a guide for local, state, and federally-sponsored soil and water conservation and nonpoint source water pollution control programs and projects.
- 4. Document the procedures that will be used by Oneida County to engage the community and to coordinate local land and resource management programs administered by county departments with those administered by state and federal agencies; and

WHEREAS, the on-going costs of implementing planned activities, as proposed in the plan, will be determined through the county budget process; and

WHEREAS, this plan is a guide and does not require that all planned activities be implemented and there are no direct fiscal impacts of plan adoption outside of existing budgeted program expenditures; and

WHEREAS, the Oneida County Conservation and UW-Extension Education Committee held a public hearing on June 5, 2019 to accept comments on the Oneida County Land and Water Resource Management Plan; and

WHEREAS, the Land and Water Conservation Board reviewed the plan and gave board recommendation for approval of that plan on August 6, 2019.

THEREFORE, **BE IT RESOLVED**, that the Oneida County Board of Supervisors does hereby approve the attached, 2020-2029 Oneida County Land and Water Resource Management Plan, with the intent to apply the plan to guide the land, water, and associated resource management activities administered under the direction of the respective County committees and departments.

BE IT FURTHER RESOLVED, that a copy of this resolution be provided to DATCP for final State approval of the plan.

WHEREAS, in August of 2018 the Department of Justice lowered the fees that they charge for open records requests; and

WHEREAS, as a result the Administration Committee reviewed the fees that Oneida County was charging for copies pursuant to open record requests; and

WHEREAS, the Administration Committee, upon review, determined that the Oneida County costs for open records should also be lowered.

NOW, THEREFORE, THE ONEIDA COUNTY BOARD OF SUPERVISORS DOES ORDAIN AS FOLLOWS:

Section 1. Any existing ordinances, codes, resolutions, or portions thereof in conflict with this ordinance shall be and hereby are repealed as far as any conflict exists.

- Section 2. This ordinance shall take effect the day after passage and publication as required by law.
- Section 3. If any claims, provisions or portions of this ordinance are adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this ordinance shall not be affected thereby.

Section 4. Section <u>1.30 & 3.25</u> of the General Code of Oneida County, Wisconsin, is amended as follows [additions noted by underline, deletions noted by strikethrough]:

§ 1.30 Public Records.

. . .

- (4) Access to Records; Fees.
 - (c) Fees.
- 1. Each authority shall impose a fee upon the requester of a copy of a record which may not exceed the actual, necessary and direct cost of reproduction and transcription of the records, [See the fee schedule set forth in Oneida County code section 3.15(2)], unless a fee is otherwise specifically established or authorized to be established by law.

[All other sections of 1.30 remain unchanged]

- § 3.15 Recording and Copying Fees.
- (2) County Department Copying Fees.
- (a) Unless otherwise permitted by Wisconsin Statutes or this code, the fee for providing a black and white copy of a document 8 1/2 inches by 11 inches in size shall be \$0.2510, per copy page provided.
- (b) The fee for providing a copy of a document of another size or a color copy shall be determined by individual department policy subject to approval by the Finance and Insurance Committee. Unless otherwise permitted by Wisconsin Statutes or this code, the fee for providing color copy of a document 8 1/2 inches by 11 inches in size shall be \$0.20, per copy page provided.
- (c) Electronic documents shall be provided free of charge. If the documents are requested to be in electronic format, and the documents exist in an electronic format, they shall be provided an electronic format. When the documents are provided on a CD/DVD the requester shall be charged \$0.20 for each CD/DVD.
