- This group is looking for two acres minimum, preferably three, in the city of Rhinelander for this project.

- They would like to start with having 10 tiny homes built. In these homes would include a half bath since the winters are too cold and slippery to have veterans walking outside in the middle of the night to go to the bathroom.
- There would also be a community center that would contain laundry facilities, showers, full kitchen and a recreation room.

#### **Social Services:**

### 1. Family First Update – Out of Home Care Statistics:

Ms. Mary Rideout presented the Out of Home Care Statistics from 2017 to 2021. This is what will be used to measure success as a result of Family First changes. There still are not any approved QRTPs. Social Services continues to work through the changes in Family First.

### 2. Contract with Forest county Department of Social Services Update:

Ms. Mary Rideout explained that we began taking Access Calls for Forest County Monday and Tuesday. We did not receive any calls for Forest County.

# 3. Request to utilize Coronavirus Local Fiscal Recover Funds (CLFRF) for Children Services Support position:

We are requesting a second Child Services Support Worker to increase visitation using ARPA funds. Looking for committee's support for this position. We will also request that both positions be 40 hours per week. The current Child Services Support Worker is 37.5 hours per week. This position will be re-evaluated yearly. Motion by Mr. Jim Winkler, seconded by Mr. Bob Thome, Jr to approve the Child Services Support Worker. All ayes; motion carried.

## 4. Agency Update - Staffing/Vacancies, Agency Renovations in 2022, Targeted Safety Support Funds (TSSF) for 2022:

- Courtney W. started as a Social Worker on November 1, 2021.

- We have begun recruitment for the Dementia Care Specialist position that was approved as part of the 2022 budget.
- We are still trying to hire a LTE to assist Public Health with outreach to older adults, caregivers, and others. We have not received any applications for this position.
- Renovations to our office area has been approved through the Capital Improvement Projects for 2022. This project is to be funded with ARPA funds received by the county.
- Oneida County DSS was approved for TSSF funds for 2022. We use these funds to provide in-home safety services to prevent the removal of children from their home. We also use them for post-reunification services to prevent children from re-entering out of home care once reunified with their parents.

## 5. 2021 Financial & Statistical Reports, Vouchers, Audit of Payments and Line Item Transfers:

The committee reviewed the Financial/Statistical Reports, Vouchers and Audit of Payment. The projected 2021 surplus for the Department of Social Services is \$87,543
