WHEREAS, in Resolution #50-2023 the County Board of Supervisors approved \$370,000 in American Rescue Plan Act (ARPA) program funding for the Solid Waste Paving Project, and

WHEREAS, the actual projected cost of the Solid Waste Paving Project is \$574,336, resulting in a funding shortfall of \$204,336, and,

WHEREAS, the County Board Supervisors has determined that a transfer of funds to the Solid Waste Department as noted below is necessary to fund the project.





WHEREAS, the Oneida County Board of Supervisors has been advised by the Administration Committee, upon recommendation of the Capital Improvement Program Subcommittee, that two projects be added to the 2023 budget, and the County Board has determined that a transfer of funds as noted below is necessary to fund the projects.

WHEREAS, the Wisconsin Statutes require a resolution adopted by the County Board under section 65.90 (5)(b) for the transfer of money for any purpose in excess of funds appropriated; and

WHEREAS, appropriations available in the 2023 ARPA Fund supported by the federal Coronavirus State and Local Fiscal Recovery Fund (SLFRF) program are \$6,913,911, but \$6,273,974 of that amount has already been expended, committed or for other projects, and

WHEREAS, contingency SLFRF fund balance is \$639,937 as of March 30, 2023 and therefore insufficient to cover these new projects in total, and

WHEREAS, an additional transfer up to \$105,063 from the General Fund may be required to cover the budget that is over, and

WHEREAS, previously approved projects may return unspent SLFRF funds when complete, and in doing so the Finance Director may return transferred funds back to the General Fund, and

THEREFORE, BE IT RESOLVED, the Oneida County Board of Supervisors approves an amendment to the 2023 ARPA Plan and further authorizes a transfer from the General Fund Unrestricted Reserves of up to \$105,063, to be returned if possible at the discretion of the Finance Director, as a supplemental appropriation.

Solid Waste is requesting ARPA Funding to cover the cost of paving at the Solid Waste facility to include the entrance, the public recycling area, the new office parking area, behind the new office up to the shop where the asphalt is extremely cut and patched, and the driving area that leads to the transfer station. Other funding sources are currently being explored to fund the eventually paving of Landfill Rd to the facility access gate.

Project Description & Justification
The roof over the annexed section of the Courthouse needs to be replaced. The rubber membrane has become permeable and cannot be replaced or repaired anymore. The breakdown of the rubber has caused the underlying insulation board to absorb water and become sponge-like. The roof over the Planning and Zoning stairwell is leaking which resulted in the closing of the staircase due to safety concern with ice being formed on the stairs. The leaking is also causing damage to paint, drywall and ceiling panels which can result in mold which would be a health hazard for the public and employees.
