

**MINUTES OF THE ONEIDA COUNTY
CIVIL SERVICE COMMISSION
January 16, 2023**

COMMISSION MEMBERS PRESENT: Chairman Tim Melms, Bernie Dart, Harry Whidden, and Pete Tenderholt.

COMMITTEE MEMBERS ABSENT: Jeff Welk

CALL TO ORDER

Chairman Melms called the meeting to order at 9:00 a.m. at the Oneida County Law Enforcement Center. The meeting was properly noticed in accordance with Wisconsin Open Meetings Laws.

DISCUSS/ACT TO APPROVE THE MINUTES OF AUGUST 5, 2022, AUGUST 8, 2022, SEPTEMBER 12, 2022

Motion by Dart to approve the minutes of August 5, 2022, August 8, 2022, and September 12, 2022, second by Melms, all ayes on voice vote, the motion carried 4-0.

DISCUSS/ACT DETECTIVE PROMOTIONAL PROCESS

Sheriff Hartman stated a Detective Sergeant would be accepting a position at the Department of Criminal Investigations. Hartman noted this opportunity offers the employee a substantial pay increase.

Motion by Whidden to begin the Detective Sergeant promotional process, second by Tenderholt, all ayes on voice vote, the motion carried 4-0.

DISCUSS/ACT TO ESTABLISH AN ELIGIBILITY LIST FOR DEPUTY SHERIFF

Sheriff Hartman stated he would like to establish an eligibility list for Deputy Sheriff positions as there would likely be two vacancies. Hartman noted that the Commission typically interviews the candidates on the same day as the testing occurs. Hartman also suggested that the interviews for Detective Sergeant take place simultaneously. The Committee indicated they would meet on March 3, 2023 and March 6, 2023.

Motion by Dart to establish an eligibility list for Deputy Sheriff, second by Whidden, all ayes on voice vote, the motion carried 4-.0

DECISIONS WHILE IN CLOSED SESSION


The Committee discussed performance evaluations. No action was taken.
