

**MINUTES OF THE ONEIDA COUNTY
CIVIL SERVICE COMMISSION
March 3, 2023**

CALL TO ORDER

Chairman Melms called the meeting to order at 8:05 a.m. at the Oneida County Law Enforcement Center. The meeting was properly noticed in accordance with Wisconsin Open Meetings Laws.

DISCUSS/ACT TO APPROVE AGENDA

Motion by Whidden to approve the agenda, second by Dart, all ayes on voice vote, the motion carried 4-0.

DISCUSS/ACT TO APPROVE THE MINUTES OF JANUARY 16, 2023.

Motion by Welk to approve the minutes of January 16, 2023, second by Dart, all ayes on voice vote, the motion carried 4-0.

All ayes on voice vote, the motion carried 5-0 and the Commission entered closed session at 8:15 a.m.

Motion by Dart to return to open session, second by Whidden. On roll call vote as follows: Whidden aye, Tenderholt aye, Melms aye, Welk aye, Dart aye, and the Commission returned to open session at 10:37 a.m.

DECISIONS WHILE IN CLOSED SESSION


