FOREST MANAGEMENT

YTD Timber Stumpage Report – Fiene reported June stumpage of \$96,839.49 bringing the year-to-date total to \$417,032.32 which is still behind the 5-year average. Markets remain pretty slow and one active job and another starting.

<u>DISCUSS/APPROVE HIGHWAY 45, TOWN OF PIEHL SNOWMOBILE TRAIL CULVERT ENGINEERING CONTRACT</u>

Rady explained the draft contract from Cooper Engineering to install some culverts in the DOT right-of-way due to a previous trail re-route. Corporation Counsel has reviewed the contract and requested additional insurance verbiage. This is a grant funded project and within the current budget.

Motion by Sorgel to approve the contract as presented with the blessing of Corporation Counsel. Second by Winkler. All aye, motion carried.

FRIENDS OF TOWNLINE LAKE PARK (FTLLP) UPDATE

Fiene stated the FTLLP group canceled the beach party event scheduled for July 15, 2023. Fiene will be meeting with a representative to discuss the placement of the permanent pier that was approved last year and a walking trail through the park.

2024 FURNITURE AND EQUIPMENT REQUEST

Fiene explained the office coordinator is requesting a sit/stand desk after completing an ergonomic assessment and providing a medical note stating this would be beneficial. The estimate came in at \$3,000 for the lift system, counter tops, etc.

Motion by Sorgel to look for used sit/stand equipment and if not, approval to forward on to Buildings and Grounds. Second by Winkler. All aye, motion carried.

VOUCHERS/LINE ITEM TRANSFERS

Vouchers for the month totaled \$5,259.98 including \$4,135.12 of grant funded projects and road aids. Next month will see an increase in expenses as voucher entry processes were held in over to enter them into the new system that went live July 1, 2023.
