CALL TO ORDER

Chairperson Gehrig called the meeting of the Local Emergency Planning Committee to order in the Community Room at the Oneida County Law Enforcement Center at 1:00 p.m. Chairperson Gehrig noted the meeting notice had been properly posted and mailed in accordance with the Wisconsin Open Meeting Law.

Introductions were conducted.

APPROVE AGENDA/MINUTES OF PREVIOUS MEETING

MOTION: To approve the Agenda (Kortenhof/Goeldner, PASSED).

MOTION: To approve the June 19, 2019 LEPC Committee Meeting Minutes (Hess/Kortenhof. Frederickson abstained from voting, motion PASSED).

RESIGNATION/APPOINTMENT OF LEPC COMMITTEE MEMBER(S)

Stan Lewis (WI DNR) was representing environmental and was hired by Woodruff Police Department. Matt Rahan is the WI DNR Regional Spill Coordinator and agreed to be on the Committee.

HAZMAT TEAM REPORT

Team representation was identified (number of members, support personnel, technician level and operations level) and Training Activity Calendar cited. There was one billable call with a Tiered II response, responsible party was billed and payment was received. Spill equipment was purchased through a HazMat grant with each municipal fire department receiving a spill kit to use on scene.

The HazMat Conference is scheduled in Stevens Point and HazMat physicals are scheduled in March at the Rhinelander Fire Department.

HazMat Chief Waydick informed the Committee of a recruitment outreach initiative to Industry to build the HazMat Team. Printpack is interested.

The Rhinelander Fire Chief addressed the importance of providing municipal fire departments with equipment to use on scene rather than having the HazMat Team respond, misuse of Team.

A Fire Chief's meeting was held at the HazMat building with spill equipment issued. Not all fire departments attended the meeting but equipment is allocated.

Appoint HazMat Assistant Chief Goeldner agreed to another term.

MOTION: To appoint Jason Goeldner as the HazMat Assistant/Deputy Chief for a two-year term (Frederickson/Hess, PASSED).
