Brockel (CA 876-A), Timber Lake Road, Town of Cassian, Part of NWNW, Section 25, T37N- R7E (Part of Parcel # CA 876-5).

Romportl discussed request and provided maps indicating the area involved in the purchase.

Motion/Timmons/Paszak to approve the request to purchase excess county lands, as presented, and forward Brockel resolution on to County Board as consent agenda item. All ayes.

Locy (LT 566-1) River Rd. Town of Lake Tomahawk. Part of NW-SW Section 7, T38N-R8E (2 parts of # LT 566-4). Romportl discussed request and provided maps indicating the area involved in the purchase. <a href="Motion/Oettinger/Pence">Motion/Oettinger/Pence to approve the request to purchase excess county lands, as presented, and forward Locy resolution on to County Board as consent agenda item. Willett (LT 146) River Rd. Town of Lake Tomahawk. Part of Gov't Lot 3, Section 12, T38N-R7E (Part of #LT 146-4). Romportl noted that the Willett request for purchase will be postponed due to needing a land survey and legal description of property to be conveyed.

## Resolution to recommend approval of the RHI Airport plat defining the boundaries of the Rhinelander – Oneida County Airport located in the Town of Crescent and City of Rhinelander.

Romportl reviewed the RHI Airport Plat, as created by Mead & Hunt. Once approved, this plat will simplify the legal descriptions for the airport property; resulting in Lots 1, 2, & 3 of the Plat of Rhinelander Airport, and some other lands across the road covered by CSM's.

Motion/Oettinger/Timmons to recommend that the RHI Airport plat be forwarded to the County Board, as a consent agenda item, for their approval to submit the Plat for reviews and/or approvals and authorizes the various County officials to sign the final Plat as reviews and approvals are obtained, subject to the City of Rhinelander also approving such submission, review, approvals, and signatures. # Resolution to convey lands from Rhinelander/Oneida County Airport Commission to City of Rhinelander and Oneida County located in Section 11, Township 36 North, Range 8 East.

Romportl reviewed and provided maps for this area. The Airport Commission cannot own land, only manage the airport property and therefor need to convey this parcel to the City and County.

Motion/Timmons/Paszak for Oneida County to accept the lands described in Deed/Document #598494, conveying from the Airport Commission to the City of Rhinelander and Oneida County, as joint tenants, and forward this item on to County Board as a consent agenda item, subject to the City also accepting the lands. All ayes.

# Resolution to convey lands from Oneida County to City of Rhinelander being Anderle DR located in SW-NE of Section 10, Township 36 North, Range 8 East.

Romportl reviewed the area of Anderle Rd. Maps were provided in the resolution.

Motion/Pence/Oettinger for Oneida County to convey to the City of Rhinelander any interest the County may have in Anderle Dr, and forward on to County Board as a consent agenda item for approval. All ayes.
