EMPLOYEE WELLNESS – ELIPTICAL EQUIPMENT PURCHASE

Charbarneau has information in agenda packets regarding the employee wellness health enhancement budget that we have. When we did our budget for next year, we are using money out of there for our employee assistance plan. We have almost \$8000 left in the 2022 budget because we didn't have inservice day and we have gotten other things at no cost this year. The 2023 budget has been reduced to \$2500, so this is probably one of the last opportunities we will have money available to purchase equipment for the exercise room down in the lower level of the courthouse. Kathy surveyed employees and got information from the people that use the exercise room. The recommendation would be to buy two refurbished elliptical machines for about the price of one new machine. \$5348 is the total cost of the two pieces of equipment and a 2-year parts and labor warranty. Motion by Scot Holewinski to approve the purchase of the two elliptical machines. Second by Ted Cushing. All Committee members present voting 'Aye'. Motion carried.

Charbarneau has information in agenda packets. These reports show Oneida County is much lower than previous years. We have had issues with needle-sticks and exposure to blood. These things will happen in a jail and with our officers. Cushing says we have minimal issues compared to other counties.
