SHERIFF'S OFFICE

Oneida County Code 5.25(2) Disposition of Duty Weapon upon Retirement: Scott Bornberg

Sheriff Hartman advised the committee that Deputy Scott Bornberg put in his retirement notice and is set to retire in January 2024 with 21+ years of service. Deputy Bornberg meets all guidelines to keep his duty weapon.

MEDICAL EXAMINER

Discuss/Approve sale of the 2015 Dodge Caravan

Me Schaub would put the revenue from the sale of the van back into the ME's budget. The van currently has 151,xxx miles on it and was well maintained. ME Schaub plans to list the van on Facebook Marketplace.
