A. Solid Vendor Vouchers

4. Solid Waste Report/Discussion

General operations report

Jolin reported she received notice at the end of their contract in 2019 Lincoln County will no longer use Oneida County for recycling. Jolin commented the loss of revenue could be made up through additional rentals of the roll-off boxes.

Jolin reported A-1 removed nine loads from the pond but did not bring all the slurry solids up noting they would likely need use a backhoe to remove the mud. Discussion regarding adding water back to the pond and hiring a company that uses an agricultural agitator and pump as a future agenda item.

Jolin reported four cleanouts for Land Information were completed with a fifth scheduled for later that day.

Jolin reported the landfill lines were in the process of being pressure tested but encountered a problem with a line. They contacted X Rooter to help resolve.

Jolin reported a second load of Hazardous Waste was sent out for the year.

Stefonek reported work for the DMA at the Eisenhower intersection is complete noting they worked with Northeast Asphalt, Lincoln and Price Counties.

Stefonek paving would begin on CTH Y would start the following Friday with the surface coat to be applied on October 30 or 31.

Stefonek reported the plan was for shoulders on CTH D to cure for one week but took longer because of rain.
